#### Al Lorenz Park: (CIP)

- 1) Pavilion #2 has been reconstructed - Complete
- 2) Recently corrected/completed a drainage issue at the inlet to the main pond - Complete
- 3) In discussion phase (have one quote as an example) for a "splash pad" in the Park.
- 4) Paving of the parking area at the entrance to the park - Complete.
- 5) Gathering materials list for the construction of another pavilion - possibly in conjunction of a splash pad – we are in the information gathering stage.

#### Murray Hill:

- 1) Building #1 – Upgrades to the conference center A/V system are being reviewed. Two quotes (Integrated and Solutions) have been received and are being evaluated.
- 2) Building # 2 – Elevator modernization - the contract is complete. It will be a September/October start - Supply chain and ordering product issue.
- 3) The wall along the roadway and parking lot of Building 6 has been re-constructed. Completed.
- 4) Building #3 - Repair and Re-Painting of exterior trim is underway
- 5) Signage - Design for new signs for all buildings is now complete.
- 6) All Buildings - Flat roof preventative maintenance - re-coating is underway

#### DOH - Dog Control expansion: (Grant)

- 1) Completed. - Additional work - Awaiting a start date from the fence company

#### Government Center (CIP):

- 1) Door locks - Day Automation – Nearing completion. Final programming of the system is underway. Day Automation is coordinating finalization of programming this week.
- 2) Probation – We will be converting/adding storage/lockers to the existing break room. This area has been repainted, additional security installed and we are working with Probation on the locker installs. Probation still reviewing potential lockers.
- 3) Interior signage. Evaluating quotes that have been received. Awaiting shop drawings from low quote.
- 4) Stairwell - This Project is under way – Anticipate completion and re-open the week of July 4<sup>th</sup>
- 5) Driveway/Parking re-paving - We are obtaining quotes, scheduling (based on least amount of interruption) for the main entrance, and all of the east parking areas for the Court House, Sheriff's Office, and Gov't Center. Hold pending funding.

#### Mental Health:

- 1) Covered walk way / entrance: This covered walk/entrance will mirror the covered walk way into dialysis. The initial stages are underway. We are awaiting one item to enable the closure of the front entrance and open a rear entrance for the public.

#### Court House:

- 1) Carpet - Contract with GP Flooring - Supply Chain 10-12 weeks for arrival of material. Once here 4 weeks to install. Appears to be an October start.

#### Sheriff's Office (CIP):

- 1) Training Center – On Hold.
- 2) Stairs from the upper to lower parking lots – Completed
- 3) Domestic Hot Water - Old Jail - Completed
- 4) Office Renovation - Materials were ordered and originally scheduled for 6 weeks out. There was an issue

WHEREAS, Livingston County is applying for funding from the NYS Community Development Block Grant (CDBG) program for a project to remove and replace qualifying owner-occupied hazardous and/or dilapidated mobile and manufactured homes in Livingston County; and

#### **3. SUPPORTING A 2022-2023 NYS LOCAL GOVERNMENT EFFICIENCY GRANT APPLICATION FOR PURCHASE OF A SHARED VACUUM TRUCK**

WHEREAS, the New York State Department of State (NYSDOS) has available funds for the 2022-2023 Local Government Efficiency (LGE) Grant Program through the Consolidated Funding Application (CFA); and

WHEREAS, Livingston County Water and Sewer Authority (LCWSA) will be submitting a NYSDOS LGE grant through the CFA program for the purchase of a dedicated vacuum truck that will be a shared resource among various Livingston County communities; and

WHEREAS, Livingston County currently operates and maintains over 760 catch basins and approximately 20 miles of storm sewer of various sizes. The general age of the infrastructure is approximately 20 years old and this responsibility includes catch basin cleaning, culvert flushing, flushing storm sewers and possibly hydro excavation when needed; and

WHEREAS, having access to a vacuum truck 24 hours/7 days a week would be beneficial specially for stormwater excavations as it would be more effective, efficient and result in less potential damage to other utilities in and around the area of excavations; and

RESOLVED, that Livingston County fully supports this effort and the NYS LGE grant application for up to \$500,000 with LCWSA providing the local match; and be it further

RESOLVED, that Livingston County will work with LCWSA to enter into an Intermunicipal Agreement (IMA) for shared use of the vacuum truck, the details of which will be finalized and signed prior to December 31, 2022.

## 8. GENESEE TRANSPORTATION COUNCIL

**2022-2023 Unified Planning Work Program: Lakeville Corridor Strategic Plan** - The RFP for consultant services has been issued. Proposals are due July 29<sup>th</sup>.

## 9. SPECIAL PROJECTS

1) Leak Detection Survey. We are working on finalizing the contract with Ground Penetrating Radar Systems so that we can get the work scheduled for this summer. We are still working with the NYS Department of State on the final grant extension approval.

2) Akzo Settlement Committee. The Committee met on June 14th to review Leicester/York water supply expansion alternatives.

**10. BROADBAND PROJECT:** Planning staff finalized the town-level analysis maps and worked with Hunt Engineers on mapping service gap areas. Our Reconnect 3 application is still pending. We were informed that we did not get the NTIA grant. The team participated in a debrief with NTIA about the application on June 27<sup>th</sup>. We are working with the State on providing them with our data to help better inform the State's broadband initiative. Reminder: The County published an App on the county website for the public to check on the status of grant activity. Empire Access, USDA and Hunt Engineers continue coordination and USDA grant implementation efforts.

**11. RADIO COMMUNICATIONS UPGRADE PROJECT.** Site construction bids for the new EOC tower were received on June 3rd. A resolution authorizing a contract with Kaplan-Schmidt, Inc. to perform the work is included for consideration by the Committee at its July meeting. C&S Engineers and Sheriff's Office continued work on the RFP for the radio antennas and related equipment. We anticipate issuing the RFP by end of June.

3. Due to anticipated low early voting turnout, we scheduled inspector training classes during the Early Voting hours. All inspectors we have scheduled to work the Primary have been scheduled to participate in these trainings.
4. There will be another Primary on August 23 for the Congressional District 24 seat currently held by Claudia Tenney. This will be a Republican only primary. We are planning to consolidate the poll sites to one in each town with the exception of Geneseo where there will be two. Early Voting will also take place at the County Building for 9 days prior to the election.
5. Some caucus for the General Election have been completed – Springwater, Geneseo, Groveland and Leicester Republicans; Mt. Morris Republicans and Democrats and Groveland Democrats. Several additional caucuses have been scheduled and must be completed by July 28.
6. Inspector reimbursements from all Villages have been received. Payments have been received from Libraries. With the exception of Dansville and Mt. Morris, all school payments have been received.
7. Thank you to Megan Sokolow for meeting with us to discuss the Records Retention Schedules and her comments for strengthening our procedures.
8. We had a conversation with Kate Hill and Jennifer Damon regarding inspector payments, payroll processing, etc. We anticipate some changes moving forward.
9. Current active voter enrollment stands at 39,291.
