WHEREAS, the hospice model involves an interdisciplinary, team-oriented approach to treatment, including expert medical care, quality symptom control, and comprehensive pain management as a foundation of care; and

WHEREAS, beyond providing physical treatment, hospice attends to the patient's emotional, spiritual and family needs, and provides family services like respite care and bereavement counseling; and

WHEREAS, palliative care delivers expertise to improve quality of life and relief from pain and can be provided at any time during an illness. Hospices are some of the best providers of community-based palliative care; and

WHEREAS, in an increasingly fragmented and broken health care system, hospice is one of the few sectors that demonstrates how health care can – and should – work at its best for its patient; and

WHEREAS, throughout the United States in 2019, 1.61 million Americans living with life-limiting illness, and their families, received care from the nation's hospice programs; and

WHEREAS, hospice and palliative care organizations are advocates and educators about advance care planning that help individuals make decisions about the care they want; and

WHEREAS, the Centers for Medicare and Medicaid Services have pledged to put patients first in all of its programs including hospice, ensuring a coordinated and patient-led approach to care, protecting patient

choice and access to individualized services based on a patient's unique care needs and wishes; now, therefore, be it

27. AMENDING A PORTION OF RESOLUTION NOS. 2019-437 AND 2019-438 (DIALYSIS EXTENSION CLINIC – WYOMING COUNTY COMMUNITY HEALTH SYSTEM)

WHEREAS, Resolution No. 2019-437 authorized the Chairman of the Livingston County Board of Supervisors to sign a lease agreement with Wyoming County Community Health System (“WCCH”) for the use of space located at 11 Murray Hill Drive, Mt. Morris, New York. Said lease was for a five (5) year period commencing January 1, 2020, at an initial monthly rental amount of \$2,673.33 with a 3% annual escalator; and

WHEREAS, Resolution No. 2019-438 authorized the Chairman of the Livingston County Board of Supervisors to sign a Letter of Intent/Letter of Agreement with WCCH for the operation of a dialysis extension clinic within the above-mentioned leased space. WCCH agreed to provide hemodialysis services to adult long-term care residents of the Livingston County Center for Nursing and Rehabilitation (“LCCNR”), as well as adult members of the community. The clinic would be open three (3) shifts a day, three (3) days a week; and

WHEREAS, hemodialysis treatments are typically three (3) times a week for three (3) to four (4) hours per dialysis session. Some of the common challenges associated with in-center hemodialysis include arranging transportation, early departure to ensure timely arrival at the facility, and finding a center capable of accommodating new patients within its operating schedule; and

WHEREAS, WCCH recently reported to the County a change in financial condition due to various fiscal pressures within its operations. As a community partner, the County wishes to assist WCCH in alleviating these pressures. Given the challenges typically associated with in-center hemodialysis, it is imperative the local dialysis extension clinic continue to operate for local residents, including long-term care patients at the LCCNR; and

WHEREAS, the County is agreeable to WCCH continuing to occupy the leased space at no cost and providing WCCH with an annual subsidy of \$150,000.00. Said subsidy would be paid in monthly installments. In exchange, WCCH agrees to continue to operate the clinic for three (3) shifts a day, a minimum of three (3) days a week. This arrangement is in the County’s best interests as it provides operational cost avoidance to the LCCNR due to keeping these necessary services on-site for long-term care patients residing at the facility; now, therefore, be it

RESOLVED, that the Chairman of the Livingston County Board of Supervisors is hereby authorized to sign amendments to the existing lease agreement and Letter of Intent/Letter of Agreement; and be it further

WHEREAS, the Livingston County Real Property Tax Services Director has prepared four (4) recommendations, applications and/or decisions (4 parcels) to correct the various tax rolls (Real Property Tax Law Sections 550 and 554); and

WHEREAS, the following corrections are hereby recommended for the 2024 tax rolls for the various towns in Livingston County; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors hereby authorizes the Livingston County Real Property Tax Services Director to apply the following corrections to the 2024 tax rolls:

1. Town of Avon

Owner: Avon Limited Partnership

Tax Map Number: 34.6-2-7.1

Reason for correction: The investigation found that due to a clerical error, the incorrect amount (\$986,000) of senior housing property tax exemption was applied to this parcel. The exemption amount of \$986,000 shall be corrected to \$1,132,500 making this parcel wholly exempt from taxation for Town and County purposes.

2. Town of Leicester

Owner: Rawhide Ranch, LLC

Tax Map Number: 79.-1-18.111

Reason for correction: The investigation found that due to an error in essential fact, this parcel was assessed with improvements that exist on another parcel. The total assessed value of this parcel shall be corrected from \$794,600 to \$591,458. Correspondingly, the agricultural exemption shall be reduced from \$444,710 to \$422,438 for Town and County purposes.

3. Town of Livonia
