**After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases was handled in the Livingston County Court before the Honorable Dennis S. Cohen on January 17, 2017.**

**LAURA A. ADAMSON**, age 33, of Groveland, charged with Burglary in the Second Degree (C Felony), Petit Larceny (Misdemeanor), and 2 counts of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to February 21, 2017.

**JOHN J. ANSON**, age 40, of Rush, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (D Felony), Failure to Keep Right, Failure to Stop at a Stop Sign and Refusal to Submit to a Field Screening Test, appeared with his attorney and the matter was adjourned to February 7, 2017.

**BENJAMIN J. BUSSEWITZ**, age 27, of Rochester was sentenced on a conviction of Petit Larceny (Misdemeanor) to time served and three years probation. He was also ordered to pay a \$200 surcharge and a \$50 DNA fee.

**ANDREW L. CAMPBELL**, age 27, of Dansville pled guilty to Grand Larceny in the Fourth Degree (E Felony) and the matter was adjourned to February 2, 2017 for sentencing.

**JOHN M. COLON**, age 27, of Rochester was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) to 2 years in state prison plus 2 years post-release supervision as a second felony offender. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and his license was suspended.

**STACEY M. EARL**, age 31, of Auburn, charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), appeared with her attorney and the matter was adjourned to January 31, 2017.

**NICOLE B.I. ETHRIDGE**, age 34, of Swain pled guilty to Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and the matter was adjourned to January 24, 2017.

**LEE A. GRIFFIN**, age 50, formerly of Groveland Correctional Facility was sentenced on a conviction of Promoting Prison Contraband in the First Degree (D Felony) to 2 ½ to 5 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**DESHAWN JAMES**, age 23, formerly of Groveland Correctional Facility, charged with Promoting Prison Contraband in the First Degree (D Felony), appeared with his attorney and the matter was adjourned to February 21, 2017.

**RACHEL L. KING**, age 32, of Mt. Morris was charged with Promoting Prison Contraband in the First Degree (D Felony), three counts of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), Criminal Possession of a Hypodermic Instrument (Misdemeanor), and Aggravated Unlicensed Operation of a Motor Vehicle in the Third Degree (Misdemeanor). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to January 24, 2017.

**KYLE A. KIBLER**, age 20, of Mt. Morris was charged with Possessing an Obscene Sexual Performance by a Child (E Felony) and Possessing a Sexual Performance by a Child (E Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to March 14, 2017.

**KYLE C. LADUE**, age 20, of Avon, charged with 19 counts of Rape in the Second Degree (D Felony), Endangering the Welfare of a Child (Misdemeanor), 2 counts of Sexual Misconduct (Misdemeanor), and Criminal Contempt Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to January 24, 2017.

**LARRY M. LANDERS, SR.**, age 51, of Groveland was sentenced on a conviction of Attempted Assault in the Second Degree (ED Felony) and Criminal Possession of Marihuana in the Second Degree (D Felony) to one to three years in state prison. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee on each charge. An Order of Protection was issued for the victim and his license was suspended.

**CAMMY R. ROBINSON**, age 39, of Rochester, charged with two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with her attorney and the matter was adjourned to March 28, 2017.

**ELTON R. SANDERS, JR.**, age 20, of Rochester, charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned for hearings.

**ERICK A. SANTIAGO**, age 33, of Geneseo pled guilty to Attempted Assault in the Second Degree (E Felony) and the matter was adjourned to January 31, 2017 for sentencing.

**KATHERINE A. SHANKEN**, age 27, of Rochester pled guilty to Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (misdemeanor) and the matter was adjourned to March 28, 2017 for sentencing.

**MELINDA E. TORRES**, age 29, of Livonia appeared on a violation of probation and the matter was adjourned to January 25, 2017. She was remanded to the Livingston County Jail without bail.

**MICHAEL W. WILLEY, JR.**, age 31, of Geneseo, charged with two counts of Burglary in the Second Degree (C Felony) and two counts of Petit Larceny (Misdemeanor.) appeared with his attorney and the matter was adjourned to February 7, 2017. Bail was continued at \$10,000.
