After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on February 21, 2017.

LAURINA M. DOW, age 38, of Wayland was sentenced on a conviction of Attempted Robbery in the Second Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), and Criminal Possession of Stolen Property in the Fourth Degree (E Felony) to 3 years in state prison plus 5 years post-release supervision as a second felony offender. She was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and an Order of Protection was issued for the victim.

SHAMON L. BEDELL, age 46, of Rochester, charged with Robbery in the Second Degree (C Felony), Grand Larceny in the Third Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), Criminal Possession of Stolen Property in the Third Degree (D Felony), Criminal Possession of Stolen Property in the Fourth Degree (E Felony), Petit Larceny (Misdemeanor), Reckless Endangerment in the Second Degree (Misdemeanor), Unlawful Fleeing a Police Office in the Third Degree (Misdemeanor), Reckless Driving (Misdemeanor), and Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to March 28, 2017.

CHASE J. FRANCIS-WHIPSET, age 27, of Caledonia, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Speeding, appeared with his attorney and the matter was adjourned to March 28, 2017.

PHILLIP J. JOHANTGEN, age 33, of Mt. Morris pled guilty to Sexual Offender Failure to Register/Verify (E Felony) and the matter was adjourned to April 25, 2017.

ROBERT L. MARTINEZ, age 24, of Canaseraga was sentenced on a conviction of Sexual Offender Failure to Register/Verify (E Felony) to 5 years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

TAHEED M. MOFFETT, age 32, of Rochester, charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony), Criminal Possession of a Controlled Substance in the Fourth Degree (C Felony), Forgery in the Second Degree (D Felony), Promoting Prison Contraband in the First Degree (D Felony), Criminal Impersonation in the Second Degree (Misdemeanor) and Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to April 11, 2017.

COREY R. MOSS, age 31, of Hemlock was sentenced on a conviction of Sexual Offender Failure to Register/Verify (E Felony) to 4 months incarceration. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

GRACE W. REID, age 29, of Lima was charged with Driving While Intoxicated (E Felony) and Operating a Motor Vehicle While on a Mobile Phone. She was arraigned with her attorney, pled not guilty, and the matter was adjourned to April 4, 2017.

EDGARDO SANTIAGO, age 36, of Mt. Morris pled guilty to Attempted Assault in the Second Degree (E Felony) and the matter was adjourned to March 14, 2017.

LUKE H. SWITZER, age 21, of Caledonia was sentenced on a conviction of Grand Larceny in the Third Degree (D Felony) to 4 months intermittent incarceration and 5 years probation to include Drug Treatment Court. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

DANIEL D. TREWER, age 41, of Wayland, convicted of Attempted Robbery in the Second Degree (D Felony), appeared with his attorney and the matter was adjourned to March 28, 2017.
