**After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on April 11, 2017.**

**A YOUTHFUL OFFENDER** was sentenced on a conviction of Criminal Mischief in the Fourth Degree (Misdemeanor) to 3 years probation. He was also ordered to pay restitution.

**SHAMON L. BEDELL**, age 46, of Rochester pled guilty to Robbery in the Second Degree (C Felony) and the matter was adjourned for sentencing.

**STACEY M. EARL**, age 31, of Auburn pled guilty to Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) and the matter was adjourned to June 6, 2017 for sentencing.

**SEBASTIAN N. MARBLE**, age 23, of Mt. Morris was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) to 1 year in state prison plus 2 years post-release supervision. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution. His license was suspended.

**ARTHUR C. MCBRIDE**, age 49, of Rochester was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (Misdemeanor) to 50 hours community service plus a surcharge.

**EDWIN PICKERING**, age 27, formerly of Groveland Correctional Facility was charged with 3 counts of Assault in the Second Degree (D Felony) and Criminal Mischief in the Third Degree (E Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 25, 2017.

**MICHAEL W. WILLEY, JR.**, age 31, of Geneseo pled guilty to 4 counts of Burglary in the Second Degree (C Felony) and 5 counts of Petit Larceny (Misdemeanor) and the matter was adjourned to May 9, 2017 for sentencing.

April 13, 2017 **LAURA A. ADAMSON**, age 33, of Groveland pled guilty to Attempted Burglary in the Second Degree (D Felony) and the matter was adjourned to June 13, 2017 for sentencing.
