**After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on April 13, 2017.**

**ERIC L. BURES**, age 42, of Honeoye was sentenced on a conviction of Driving While Intoxicated (E Felony) to 1½ to 4 years in state prison. He was also ordered to pay a \$520 surcharge, a \$50 DNA fee, and his license was revoked with a requirement to install an Ignition Interlock Device.

**CURTIS J. MCFARLAND**, age 27, of Rochester, charged with Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) and Criminal Mischief in the Third Degree (E Felony), appeared with his attorney and the matter was adjourned to April 20, 2017.

**PEGGY M. MERRILL**, age 34, of Geneseo, charged with Forgery in the Second Degree (D Felony), Identity Theft in the Second Degree (E Felony), and Theft of Services (Misdemeanor), appeared without an attorney and the matter was adjourned to April 20, 2017.

**ERIC W. MEYERS**, age 35, of Lima pled guilty to Aggravated Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony) the matter was adjourned to June 21, 2017 for sentencing.

**CALVIN R. PATRICK**, age 35, of Mt. Morris pled guilty to Attempted Rape in the First Degree (C Felony) and the matter was adjourned to July 13, 2017 for sentencing.

**JOANNE ROBERTS**, age 34, of Mt. Morris was sentenced on a violation of probation to time served and continued probation.

**MATTHEW K. SACKETT**, age 22, of Springwater, charged with Assault in the First Degree (B Felony), Assault in the Second Degree (D Felony), Reckless Assault of a Child (D Felony), Endangering the Welfare of a Child (Misdemeanor), 2 counts of Making a Punishable False Written Statement and 2 violations of probation, appeared with his attorney and the matter was adjourned for May 4, 2017.

**DAWN M. WATSON**, age 38, of Conesus, charged with Offering a False Instrument for Filing in the First Degree (E Felony), Falsifying Business Records in the First Degree (E Felony), Welfare Fraud in the Fourth Degree (E Felony), Grand Larceny in the Fourth Degree (E Felony), and Misuse of Food Stamps (E Felony), appeared with her attorney and the matter was adjourned to May 11, 2017.

**JEREMIAH D. YOUNG**, age 42, of Prattsburg, charged with Driving While Impaired by Drugs (Felony), Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), and Speeding, appeared with his attorney and the matter was adjourned to May 4, 2017.
