**After presentation by Gregory J. McCaffrey, District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on June 13, 2017.**

**LAURA A. ADAMSON**, age 33, of Groveland was sentenced on a conviction of Attempted Burglary in the Second Degree (D Felony) to 2 years in state prison plus 3 years post-release supervision. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**ROBERT CANFIELD**, age 36, of Irondequoit admitted violating probation and the matter was adjourned to August 8, 2017.

**STACEY M. EARL**, age 31, of Auburn was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) to 4 months intermittent incarceration and 5 years probation. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**FELIX M. FANTAUZZI**, age 53, of Newark was resentenced to 45 days incarceration upon a violation of intermittent incarceration.

**JANET FLORES**, age 41, of Rochester pled guilty to Attempted Criminal Possession of a Controlled Substance in the Third Degree (C Felony) and the matter was adjourned to August 15, 2017 for sentencing.

**LON F. JARRELL**, age 62, of Lima, charged with Driving While Intoxicated (E Felony), Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Failure to Maintain Lane, and Failure to Keep Right, appeared with his attorney and the matter was adjourned to June 27, 2017.

**KYLE A. KIBLER**, age 20, of Mt. Morris, pled guilty to Possessing an Obscene Sexual Performance by a Child (E Felony) and the matter was adjourned to June 27, 2017 for sentencing.

**JOHN W. LANDER, III.**, age 51, of Rochester was sentenced on a conviction of Criminally Negligent Homicide (E Felony) to 4 months intermittent incarceration. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**JENNIFER J. LOPEZ**, age 28, of Rochester, charged with Promoting Prison Contraband in the First Degree (D Felony), Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), and Promoting Prison Contraband in the Second Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to August 29, 2017.

**ANNIE L. MALARA**, age 30, of Elmira was charged with Welfare Fraud in the Third Degree (D Felony), Grand Larceny in the Third Degree (D Felony), Misuse of Food Stamps (E Felony), and 2 counts of Offering a False Instrument for Filing in the First Degree (E Felony). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to July 11, 2017.

**ROBERT G. MALLIOUX**, age 46, formerly of Groveland Correctional Facility, pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to August 8, 2017 for sentencing.

**TAVARES L. MCMATH**, age 26, of Rochester, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Speeding, appeared without an attorney and the matter was adjourned to June 27, 2017.

**DENNIS E. NELSON**, age 30, of Lima pled guilty to Attempted Criminal Possession of Marihuana in the Second Degree (E Felony) and the matter was adjourned to June 20, 2017 for sentencing.

**KRISTY L. PEFFERS**, age 39, of Leicester was sentenced on a conviction of Grand Larceny in the Second Degree (C Felony) to 5 years probation. She was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

**A YOUTHFUL OFFENDER** was sentenced on a conviction of Sexual Abuse in the First Degree (D Felony) to 4 months intermittent incarceration and 10 years probation to include Sexual Offender registration. An Order of Protection was used for the victim.

**KEITH R. WAITE**, age 46, of Mt. Morris was charged with Assault in the Second Degree (D Felony) and Criminal Possession of a Weapon the Fourth Degree (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to August 15, 2017.
