**After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on August 8, 2017.**

**ROBERT CANFIELD**, age 37, of Irondequoit was sentenced on a violation of probation to 1½ to 4 years in state prison.

**MICHAEL C. CHASE**, age 25, of Hornell, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Impaired by Drugs (Misdemeanor), and Failure to Use a Turn Signal, appeared with his attorney and the matter was adjourned to August 29, 2017.

**ROBERT L. FLYNN**, age 48 of Victor, charged with Driving While Intoxicated (D Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Operating Without Ignition Interlock Device, Unlawful Fleeing a Police Officer, Reckless Driving, Harassment in the Second Degree, Failure to Keep Right, Possession of an Alcoholic Beverage in a Motor Vehicle, 3 counts of Speeding, 2 counts of Failure to Stop at a Stop Sign, and Refusal to Submit to a Field Screening Device, appeared with his attorney and the matter was adjourned for hearings. Bail was revoked.

**CHASE J. FRANCIS-WHIPSET**, age 28, of Caledonia, convicted of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), appeared with his attorney and the matter was adjourned to September 12, 2017 for sentencing.

**STEFFAN JK HAMPSHIRE**, age 22, of Nunda, charged with Criminal Possession of a Controlled Substance in the Fourth Degree (C Felony) and Inadequate Exhaust, appeared with his attorney and the matter was adjourned to August 22, 2017.

**LON F. JARRELL**, age 62, of Lima pled guilty to Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony) and the matter was adjourned to September 12, 2017 for sentencing.

**LEQUAN M. HILL**, age 24, formerly of Livingston Correctional Facility, pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to October 10, 2017 for sentencing.

**ROBERT G. MALLIOUX**, age 46, formerly of Groveland Correctional Facility was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 1½ to 3 years in state prison as a second felony offender.

**CHARLES PHELPS**, age 24, formerly of Livingston Correctional Facility, charged with Promoting Prison Contraband in the First Degree (D Felony), appeared with his attorney and the matter was adjourned to September 12, 2017 for sentencing.

**CHRISTINE WIEPERT**, age 52, of Leicester, charged with 4 counts of Grand Larceny in the Third Degree (D Felony), Falsifying Business Records in the First Degree (E Felony), Insurance Fraud in the Third Degree (D Felony), and Fraudulent Practices (E Felony), appeared with her attorney and the matter was adjourned to August 22, 2017.

**JASON L. ZIENKIEWICZ**, age 32, of Rochester was charged with Driving While Intoxicated (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the Third Degree (Misdemeanor), Speeding, and Refusal to Submit to a Field Screening Device. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to September 26, 2017.
