**After presentation by Justin M. Hill, Assistant District Attorney, the following case was handled in the Livingston County Court before the Honorable Dennis S. Cohen on December 15, 2016.**

**MICHAEL A. BELL**, age 29, of Livonia, charged with Driving While Intoxicated (E Felony) and Failure to Maintain Lane, appeared with his attorney and the matter was adjourned to January 26, 2017.

**BREENNA C. BORTLE**, age 21, of Dansville, charged with Grand Larceny in the Fourth Degree (E Felony), Criminal Possession of Stolen Property Fourth Degree (E Felony), Petit Larceny (Misdemeanor), and Conspiracy in the Fifth Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to January 5, 2017.

**STEPHEN H. CASSIDY**, age 41, of Olean was sentenced on a conviction of Tampering with Physical Evidence (E Felony) to 1 ½ to 3 year in state prison as a second felony offender. He was also ordered to pay a \$325 penalty assessment and a \$50 DNA fee.

**CHAD M. CURTS**, age 33, of Caledonia admitted a violation of probation and the matter was adjourned to February 9, 2017 for sentencing. He was remanded to the Livingston County Jail without bail.

**MELISSA C. DRISCOLL**, age 34, of Avon, charged with Grand Larceny in the Fourth Degree (E Felony), appeared with her attorney and the matter was adjourned to December 22, 2016.

**ORLANDO HERNANDEZ**, age 43, of Rochester, convicted of 2 counts of Assault in the Second Degree (D Felony), appeared with his attorney and the matter was adjourned to March 9, 2017.

**KENNETH R. KIEHLE**, age 42, of Dansville was charged with Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 12, 2017.

**KYLE J. KNAAK**, age 25, of Dansville appeared on a violation of probation, entered a denial, and the matter was adjourned to December 22, 2016. He was remanded to the Livingston County Jail without bail.

**ALONSO MCGEE**, age 56, of Rochester was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Driving While Intoxicated (Misdemeanor) to 4 months intermittent incarceration and 3 years probation to include electronic home monitoring. He was also ordered to pay a \$520 surcharge, a \$50 DNA fee, and his license was revoked with a requirement to install an Ignition Interlock Device.

**WENDY TEETER**, age 43, of Dansville admitted a violation of probation and was sentenced to continue probation with the addition of drug treatment court.

**FRANK C. TOLEDO**, age 31, of Miami, charged with 2 counts of Identity Theft in the First Degree (D Felony) and 3 counts of Criminal Possession Forged Instrument in the Second Degree (D Felony), appeared with his attorney and the matter was adjourned to January 5, 2017.
