After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals on December 14, 2016.

CORY A. CURRY age 26, of Nunda was charged with Driving While Ability Impaired by Drugs (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Failure to Stay in Lane.

LAURA A. ADAMSON, age 33, of Groveland was charged with Burglary in the Second Degree (C Felony), Petit Larceny (Misdemeanor), and 2 counts of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor).

BRANDON M. DIOGUARDI, age 24, of Mt. Morris was charged with 3 counts of Forgery in the Second Degree (D Felony) and Petit Larceny (Misdemeanor).

GILBERTO R. LEBRON, age 34, of Mt. Morris was charged with Promoting Prison Contraband in the First Degree (E Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor).

DAWN M. WATSON, age 38, of Conesus was charged with 2 counts of Offering a False Instrument for Filing in the First Degree (E Felony), 2 counts of Falsifying Business Records in the First Degree (E Felony), Welfare Fraud in the Fourth Degree (E Felony), Grand Larceny in the Fourth Degree (E Felony), and Misuse of Food Stamps (E Felony).

ALEXANDER M. GRAVESANDY, age 30, of Rochester was charged with Criminal Contempt in the First Degree (E Felony).

CLARENCE O. WARD, age 48, of Dansville was charged with 2 counts of Offering a False Instrument for Filing in the First Degree (E Felony), 2 counts of Falsifying Business Records in the First Degree (E Felony), Welfare Fraud in the Fourth Degree (E Felony), Grand Larceny in the Fourth Degree (E Felony), and Misuse of Food Stamps (E Felony).

CHARLES F. LEWIS, age 33, of Bloomfield was charged with Grand Larceny in the Third Degree (D Felony) and Issuing a Bad Check (B Misdemeanor).
