**After presentation by Joshua J. Tonra, Assistant District Attorney, the following case was handled in the Livingston County Court before the Honorable Robert B. Wiggins on December 6, 2016.**

**LAURINA M. DOW**, age 37, of Wayland, charged with Robbery in the First Degree (B Felony), two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), and Tampering with Physical Evidence (E Felony), and also convicted of Grand Larceny in the Fourth Degree (E Felony) and Criminal Possession of Stolen Property in the Fourth Degree (E Felony), appeared with her attorney and the matter was adjourned to December 20, 2016.

**STACEY M. EARL**, age 31, of Auburn, charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), appeared with her attorney and the matter was adjourned to January 3, 2017.

**AMIE M. GOMOLL**, age 33, of Conesus appeared on a violation of probation and the matter was adjourned to January 3, 2017. She was remanded to the Livingston County Jail without bail.

**MICHAEL D. HAZZARD**, age 26, of Rochester, convicted of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Criminal Contempt in the Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to January 3, 2017.

**JOHN PATRICK MANN** age 26, of Nunda was sentenced on a conviction of Grand Larceny in the Fourth Degree (E Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor) to 1½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**BRETT J. PHILLIPS**, age 28, of Livonia, charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony), 2 counts of Criminal Possession of a Weapon in the Third Degree (D Felony), Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor), and Criminal Use of Drug Paraphernalia in the Second Degree (misdemeanor), appeared with his attorney and the matter was adjourned to December 16, 2016 for a hearing.

**CAMMY R. ROBINSON**, age 39, of Rochester, charged with two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with her attorney and the matter was adjourned to January 17, 2017.

**ELTON R. SANDERS, JR.**, age 20, of Rochester, charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to January 17, 2017.

**MICHAEL W. WILLEY, JR.**, age 31, of Geneseo was charged with two counts of Burglary in the Second Degree (C Felony) and two counts of Petit Larceny (Misdemeanor.) He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 17, 2017. Bail was set at \$10,000.
