After presentation by Justin M. Hill, Assistant District Attorney, the following case was handled in the Livingston County Court before the Honorable Dennis S. Cohen on December 1, 2016.

PARIS D. BELLFIELD, age 37, of Fulton was charged with Welfare Fraud in the Fourth Degree (E Felony), Grand Larceny in the Fourth Degree (E Felony), and Misuse of Food Stamps (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to February 9, 2017.

MICHAEL J. DANN, JR., age 28, of Dansville, charged with Sexual Offender Failure to Register or Verify (D Felony), appeared with his attorney and the matter was adjourned to February 2, 2017.

MICHAEL F. GERHARDT, age 49, of Livonia was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Driving While Intoxicated (Misdemeanor) to 179 days incarceration and 5 years probation to include Drug Treatment Court. He was also ordered to pay a \$520 surcharge, a \$50 DNA fee, and his license was revoked with a requirement to install an Ignition Interlock Device.

ANTONIO D. HILLIARD, age 36, of Rochester pled guilty to Criminal Possession of a Weapon in the Fourth Degree (Misdemeanor) and the matter was adjourned to February 2, 2017 for sentencing. He was remanded to the Livingston County Jail without bail.

SHAWN M. NORMAN, age 50, of Mt. Morris was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (Misdemeanor), Unauthorized Use of a Vehicle in the Third Degree (Misdemeanor), and Failure to Maintain Lane. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to February 9, 2017.

ANGEL G. PABON, age 36, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Speeding, Inadequate Tail Lights, and Operating a Motor Vehicle with Less Than 70% Light Transmittance. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to February 2, 2017. Bail was set at \$1500.

MATTHEW K. SACKETT, age 21, of Springwater, charged with two counts of Rape in the Third Degree (E Felony), Criminal Contempt in the Second Degree (Misdemeanor), and two counts of Endangering the Welfare of a Child (Misdemeanor), appeared with his attorney and the matter was adjourned to December 8, 2016.

BRYAN A. SKINNER, age 29, of Hemlock, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Unsafe Backing, and Failure to Stay in Lane, appeared with his attorney and the matter was adjourned to January 12, 2017.

SHAWN M. WILLIAMS, age 29, of Rochester, charged with Driving While Intoxicated (E Felony) and Speeding, appeared with his attorney and the matter was adjourned to December 22, 2016.
