**After presentation by Gregory J. McCaffrey, District Attorney, the following case was handled in the Livingston County Court before the Honorable Robert B. Wiggins on November 22, 2016.**

**JOHN M. CHABUEL, II.**, age 22, of Olean was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Fifth Degree (D felony) to 2 ½ years in state prison plus 2 years post-release supervision as a second felony offender. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and his license was suspended.

**COLLIN J. DAVIS**, age 22, of Conesus admitted a violation of probation and the matter was adjourned to December 20, 2016 for sentencing. He was remanded to the Livingston County Jail without bail.

**DESHAWN JAMES**, age 23, formerly of Groveland Correctional Facility was charged with Promoting Prison Contraband in the First Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 20, 2016.

**JAMES C. JONES, JR.**, age 32, of Rochester was sentenced on a conviction of Criminal Possession of a Weapon in the Second Degree (C Felony) to 7 years in state prison plus 5 years post-release supervision as second violent felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**TYSHAWN JONES**, age 19, of Brooklyn, pled guilty to Assault in the Second Degree (D Felony), Criminal Impersonation in the Second Degree (Misdemeanor), Resisting Arrest, Criminal Possession of Marijuana Fifth Degree (B Misdemeanor), Speeding, and Unlicensed Operator, and the matter was adjourned to January 10, 2017 for sentencing. He was remanded to the Livingston County Jail without bail.

**ROBERT C. KENDALL**, age 33, of North Rose, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (E Felony), Failure to Stop at a Stop Sign, Improper U-Turn, and Possession of an Alcoholic Beverage in a Motor Vehicle, appeared without his attorney and the matter was adjourned to December 6, 2016.

**KYLE C. LADUE**, age 20, of Avon was charged with eighteen counts of Rape in the Second Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 20, 2016. Bail was set at \$5,000.

**JOHN PATRICK MANN** age 26, of Nunda, charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor), appeared without his attorney and the matter was adjourned to December 6, 2016.

**LOIS L. MARK**, age 53, of Dansville appeared on a violation of probation and the matter was adjourned to December 7, 2016 for a hearing.

**A YOUTHFUL OFFENDER** was charged with Burglary in the Third Degree (D Felony), Criminal Mischief in the Second Degree (D Felony), Criminal Mischief in the Third Degree (E Felony), Petit Larceny (Misdemeanor), and Making Graffiti (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 17, 2017.

**TERRY J. MASSEY**, age 51, of Dansville, convicted of Driving While Intoxicated (E Felony), appeared with his attorney and the matter was adjourned to January 10, 2017 for sentencing.

**RYAN P. MOSHER**, age 24, of Mt. Morris was sentenced on a conviction of Forgery in the Second Degree (D Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), and Driving While Ability Impaired by Drugs (Misdemeanor), to 2 ½ to 5 years in state prison as a second felony offender He was also ordered to pay surcharges and DNA fees.

**BRETT J. PHILLIPS**, age 28, of Livonia, charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony), 2 counts of Criminal Possession of a Weapon in the Third Degree (D Felony), Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor), and Criminal Use of Drug Paraphernalia in the Second Degree (misdemeanor), appeared with his attorney and the matter was adjourned to December 6, 2016.

**CAMMY R. ROBINSON**, age 39, of Rochester, charged with two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared without an attorney and the matter was adjourned to December 6, 2016.

**ELTON R. SANDERS, JR.**, age 20, of Rochester, charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared without an attorney and the matter was adjourned to December 6, 2016.

**ERICK A. SANTIAGO**, age 33, of Geneseo, charged with Attempted Gang Assault in the First Degree (C Felony) and Attempted Assault in the Second Degree (E Felony), appeared with his attorney and the matter was adjourned to January 17, 2017.

**GREGORY K. WALSH**, age 26, of Geneseo, pled guilty to Vehicular Assault in the First Degree (D Felony), Assault in the Second Degree (D Felony), and admitted a violation of probation. Sentencing is scheduled for December 20, 2016 and he was remanded to the Livingston County Jail without bail.
