After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on November 17, 2016.

**MICHAEL G. BENNETT**, age 23, of Dansville was sentenced on a conviction of Grand Larceny in the Fourth Degree (E Felony) 2 months intermittent incarceration and 5 years probation. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

**ANN MARIE BOUDREAU**, age 29, of Rochester, charged with Burglary in the First Degree (B Felony), Criminal Possession of a Weapon in the Third Degree (D Felony), Menacing in the Second Degree (Misdemeanor), Petit Larceny (Misdemeanor), and Criminal Possession of a Hypodermic Instrument (Misdemeanor), appeared with her attorney and the matter was adjourned to January 11, 2017 for hearings.

**JONATHAN A. CADY**, age 26, of Leicester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (E Felony), Failure to Keep Right, and Refusal to Submit to Field Screening Test. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 22, 2016. His license was suspended pending prosecution.

**EMILY J. FUETTERER**, age 30, of Livonia was charged with Aggravated Driving While Intoxicated with a Child Under 16 years old (E Felony), Driving While Impaired by Drugs (E Felony), Endangering the Welfare of a Child (Misdemeanor), Inadequate Lights, and Resisting Arrest. She was arraigned with her attorney, pled not guilty, and the matter was adjourned to February 2, 2017.

**MICHAEL F. GERHARDT**, age 49, of Livonia was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (Misdemeanor), Speeding, Failure to Keep Right, Failure to Comply with a Lawful Order, and Possession of an Alcoholic Beverage in a Motor Vehicle. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 1, 2016.

**UGEEN D. GOINS**, age 39, of Rochester pled guilty to Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and the matter was adjourned to February 2, 2017 for sentencing. He was remanded to the Livingston County Jail without bail.

**A YOUTHFUL OFFENDER** pled guilty to Attempted Arson in the Third Degree (D Felony) and the matter was adjourned to January 12, 2017 for sentencing.

**ANTONIO D. HILLIARD**, age 36, of Rochester, charged with Criminal Possession of a Weapon in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to December 1, 2016. Bail was continued at \$5,000.

**BRYAN A. SKINNER**, age 29, of Hemlock was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Unsafe Backing, and Failure to Stay in Lane. He was arraigned without an attorney, pled not guilty, and the matter was adjourned to December 1, 2016 to appear with his attorney.

**RICHARD S. WILSON**, age 47, of Rochester pled guilty to Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony) and the matter was adjourned to January 12, 2017 for sentencing. He was remanded to the Livingston County Jail without bail.
