After presentation by Joshua J. Tonra, Assistant District Attorney, the following case was handled in the Livingston County Court before the Honorable Robert B. Wiggins on September 27, 2016.

DAVIN M. L. BONNER, age 24, of Mt. Morris was sentenced on a conviction of Assault in the Second Degree (D Felony) to 4 years in state prison plus 5 years post-release supervision. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

NATASHA A. BOUTON, age 45, of Cameron Mills was charged with Aggravated Driving While Intoxicated with a Child (E Felony), Driving While Impaired by Drugs (Misdemeanor), Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), Endangering the Welfare of a Child (Misdemeanor), and Failure to Use a Turn Signal. She was arraigned with her attorney, pled not guilty, and the matter was adjourned to October 18, 2016. Bail was set at \$2,000.

ANDREW L. CAMPBELL, age 26, of Dansville, charged with Grand Larceny in the Fourth Degree (E Felony), Petit Larceny (Misdemeanor), two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and a violation of probation, appeared with his attorney and the matter was adjourned to October 11, 2016.

LAURINA M. DOW, age 37, of Wayland, charged with Robbery in the First Degree (B Felony), two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), and Tampering with Physical Evidence (E Felony), appeared with her attorney and the matter was adjourned to November 1, 2016.

GAVIN J. DYKE, age 21, of Mt. Morris was sentenced on a violation of probation to 2 additional months of intermittent incarceration.

NICOLE B.I. ETHRIDGE, age 34, of Dansville, charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with her attorney and the matter was adjourned to October 18, 2016.

FRANKLIN A. GAY, age 41, of Rochester was sentenced on a conviction of Tampering with Physical Evidence (E Felony) to 1½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

KYLE C. LADUE, age 20, of Avon, charged with 2 counts of Rape in the Second Degree (D Felony), Criminal Sexual Act Second Degree (D Felony), Endangering the Welfare of a Child (Misdemeanor), 2 counts of Sexual Misconduct (Misdemeanor), and Criminal Contempt Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned for hearings. Bail was continued at \$5,000.

LARRY M. LANDERS, SR., age 51, of Groveland, charged with Assault in the Second Degree (D Felony), Criminal Obstruction Breathing or Blood Circulation (Misdemeanor), Criminal Possession of Marihuana in the Second Degree (D Felony) and three counts of Criminal Possession of Weapon in the Fourth Degree (Misdemeanor), appeared with his attorney and the matter was adjourned for hearings.

LOIS L. MARK, age 53, of Dansville, charged with Criminal Contempt in the First Degree (E Felony), Criminal Mischief in the Third Degree (E Felony), Attempted Assault in the Second Degree (E Felony), and Reckless Endangerment in the First Degree (D Felony), appeared with her attorney and the matter was adjourned to October 4, 2016. Bail was continued at \$3500.

NATHAN J. PASCUZZO, age 24, of Lakeville was sentenced on a conviction of Petit Larceny (Misdemeanor) to a 1 year conditional discharge and was ordered to pay a \$200 surcharge and a \$50 DNA fee.

BRETT J. PHILLIPS, age 28, of Livonia, charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony), 2 counts of Criminal Possession of a Weapon in the Third Degree (D Felony), Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor), and Criminal Use of Drug Paraphernalia in the Second Degree (misdemeanor), appeared with his attorney and the matter was adjourned to November 22, 2016. Bail was set at \$2,500.

FRANK SANTANA, age 25, of Rochester, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Speeding, appeared with his attorney and the matter was adjourned to October 11, 2016.

SEAN M. SULLIVAN, age 28, of Rochester was sentenced on a conviction of Petit Larceny (Misdemeanor) to time-served and three years probation. He was also ordered to pay restitution and the \$50 DNA fee.

TRICIA A. THOMPSON, age 40, of Dansville, charged with Sex Offender Failure to Register or Verify (E Felony), appeared with her attorney and the matter was adjourned to October 4, 2016.

GREGORY K. WALSH, age 26, of Geneseo, charged with Vehicular Assault in the First Degree (D Felony), Assault in the Second Degree (D Felony), Driving While Impaired by Drugs (Misdemeanor), Driving While Impaired by Drugs and Alcohol (Misdemeanor), Failure to Maintain Lane, and a violation of probation, appeared with his attorney and the matter was adjourned to October 18, 2016.
