**After presentation by Gregory J. McCaffrey, District Attorney, the following case was handled in the Livingston County Court before the Honorable Robert B. Wiggins on September 6, 2016.**

**DAVIN M. L. BONNER**, age 24, of Mt. Morris, charged with Assault in the Second Degree (D Felony), appeared with his attorney and the matter was adjourned for a trial date.

**JAMES R. BROWN**, age 32, of Rochester, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), appeared with his attorney and the matter was adjourned to October 4, 2016.

**NAPOLEON S. BRYAN**, age 23, of Dansville was sentenced on a conviction of Attempted Criminal Possession Controlled Substance in the Third Degree (C Felony) to 2 years' in state prison as a second felony offender plus 3 years post-release supervision. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and his license was suspended.

**ANDREW L. CAMPBELL**, age 26, of Dansville, charged with Grand Larceny in the Fourth Degree (E Felony), Petit Larceny (Misdemeanor), two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and a violation of probation, appeared with his attorney and the matter was adjourned to September 27, 2016.

**NICOLE B.I. ETHRIDGE**, age 34, of Dansville was charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Third Degree (B Felony.) She was arraigned with her attorney, pled not guilty, and the matter was adjourned to September 27, 2016.

**BRANDON E. JENKINS**, age 35, of Mt. Morris pled guilty to Grand Larceny in the Fourth Degree (E Felony) and the matter was adjourned to November 1, 2016 for sentencing. He was remanded to the Livingston County Jail without bail.

**LARRY M. LANDERS, SR.**, age 51, of Groveland, charged with Assault in the Second Degree (D Felony), Criminal Obstruction Breathing or Blood Circulation (Misdemeanor), Criminal Possession of Marihuana in the Second Degree (D Felony) and three counts of Criminal Possession of Weapon in the Fourth Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to September 13, 2016.

**TERRY J. MASSEY**, age 51, of Dansville pled guilty to Driving While Intoxicated (E Felony) and the matter was adjourned to November 22, 2016 for sentencing.

**NATHAN J. PASCUZZO**, age 24, of Lakeville pled guilty to Petit Larceny (Misdemeanor) and the matter was adjourned to September 27, 2016.

**TIMOTHY J. PASSAGE**, age 32, formerly of Livingston Correctional Facility pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to November 1, 2016 for sentencing. He was remanded to the Livingston County Jail without bail.

**CHASTITY A. SIMMONS**, age 39, of Rochester was charged with 6 counts of Promoting Prison Contraband in the First Degree (D Felony), 6 counts of Falsifying Business Records in the First Degree (E Felony), and 6 counts of Official Misconduct (Misdemeanor.) She was arraigned with her attorney, pled not guilty, and the matter was adjourned to October 18, 2016.

**GREGORY K. WALSH**, age 26, of Geneseo, charged with charged with Vehicular Assault in the First Degree (D Felony), Assault in the Second Degree (D Felony), Driving While Impaired by Drugs (Misdemeanor), Driving While Impaired by Drugs and Alcohol (Misdemeanor), Failure to Maintain Lane, and a violation of probation, appeared with his attorney and the matter was adjourned for further proceedings.

**MATTHEW WELLS**, age 20, of Geneseo admitted a violation of probation and the matter was adjourned to November 1, 2016 for sentencing. He was remanded to the Livingston County Jail without bail.

**RYAN T. O'MAY**, age 25, of Avon pled guilty (on September 7, 2016) to Bribe Receiving in the Third Degree (D Felony) and the matter was adjourned for October 11, 2016 for sentencing.
