**After presentation by Joshua J. Tonra, Assistant District Attorney, the following case was handled in the Livingston County Court before the Honorable Robert B. Wiggins on August 9, 2016.**

**DAVIN M. L. BONNER**, age 24, of Mt. Morris, charged with Assault in the Second Degree (D Felony), appeared with his attorney and the matter was adjourned to August 23, 2016.

**COLLIN J. DAVIS**, age 22, of Conesus was sentenced on a conviction of Attempted Rape in the Third Degree (Misdemeanor) to 6 years probation. He was also ordered to pay a \$200 surcharge, a \$50 DNA fee, and a \$1,000 Sexual Offender Registry fee. An Order of Protection was issued for the victim.

**LAURINA M. DOW**, age 37, of Wayland was charged with Robbery in the First Degree (B Felony), two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), and Tampering with Physical Evidence (E Felony.) She was arraigned with her attorney, pled not guilty, and the matter was adjourned to September 13, 2016. Bail was set at \$25,000.

**JUSTIN S. FORD**, age 33, of Livonia pled guilty to Criminal Sale of Marihuana in the Second Degree (D Felony) and the matter was adjourned to October 4, 2016.

**KYLE C. LADUE**, age 20, of Avon, charged with 2 counts of Rape in the Second Degree (D Felony), Criminal Sexual Act Second Degree (D Felony), Endangering the Welfare of a Child (Misdemeanor), 2 counts of Sexual Misconduct (Misdemeanor), and Criminal Contempt Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to September 13, 2016. Bail was set at \$5,000 and an Order of Protection was issued for the victim.

**TERRY J. MASSEY**, age 51, of Cohocton, charged with Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), and Failure to Exercise Due Care to an Emergency Vehicle, appeared without an attorney and the matter was adjourned to August 10, 2016.

**JUSTIN C. MOREY**, age 27, of Wayland appeared on a probation matter and the case was adjourned to August 12, 2016.

**THOMAS J. RYAN, III**, age 23, of Lima, charged with Driving While Intoxicated (E Felony) and Unsafe Backing, appeared with his attorney and the matter was adjourned for hearings.

**ADAM L. SIMZER**, age 33, of Conesus appeared on a probation matter and the case was adjourned to August 10, 2016. He is remanded to the Livingston County Jail without bail.

**JACOB SUTTON**, age 23, of Avon was sentenced on a violation of probation to 1 year in the Livingston County Jail and his probation was revoked.

**GREGORY K. WALSH**, age 25, of Livonia was charged with Vehicular Assault in the First Degree (D Felony), Assault in the Second Degree (D Felony), 2 counts of Driving While Impaired by Drugs (Misdemeanor), and Failure to Maintain Lane. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to August 30, 2016. Bail was set at \$20,000. He also appeared on a violation of probation and the matter was adjourned to August 30, 2016. He was remanded to the Livingston County Jail without bail.
