After presentation by Gregory J. McCaffrey, District Attorney, the following case was handled in the Livingston County Court before the Honorable Robert B. Wiggins on July 12, 2016.

COLLIN J. DAVIS, age 21, of Conesus, charged with Rape in the Third Degree (E Felony) and Sexual Abuse in the First Degree (D Felony), appeared with his attorney and the matter was adjourned to August 9, 2016.

DAWN N. DIPILATO, age 34, of Honeoye, charged with Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to August 2, 2016.

AMIE M. GOMOLL, age 33, of Conesus pled guilty to Attempted Burglary in the Second Degree (D Felony) and the matter was adjourned to July 26, 2016 for sentencing. Bail was continued at \$4,000.

ROY H. LANE, age 67, of Mt. Morris was sentenced on a conviction of Sexual Abuse in the First Degree (D Felony) to 2 years' in state prison plus 10 years post-release supervision. He was also ordered to pay surcharges, DNA fees, and New York State Sexual Offender registry fees. An Order of Protection was issued for the victim.

TERRY J. MASSEY, age 51, of Cohocton was charged with Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), and Failure to Exercise Due Care to an Emergency Vehicle. He was arraigned without an attorney, pled not guilty, and the matter was adjourned to July 26, 2016. His license was suspended pending prosecution.

TIMOTHY A. MILLS, age 34, of Honeoye, charged with Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) and Inadequate Exhaust, appeared with his attorney and the matter was adjourned to August 9, 2016. Bail was continued at \$2,000.

DUSTIN D. NEU, age 35, of Dansville was sentenced on a conviction of Criminal Sale of a Controlled Substance in the Fourth Degree (C Felony) to 6 months in the Livingston County Jail and 5 years' probation. He was also ordered to pay restitution and a \$50 DNA fee.

PETER R. ROGERS, age 39, of Geneseo pled guilty to Burglary in the Third Degree (D Felony) and the matter was adjourned to August 2, 2016 for sentencing. He was remanded to the Livingston County Jail without bail.

THOMAS J. RYAN, III, age 23, of Lima was charged with Driving While Intoxicated (E Felony) and Unsafe Backing. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to August 2, 2016. His license was suspended pending prosecution.

SEAN M. SULLIVAN, age 28, of Rochester pled guilty to Petit Larceny (Misdemeanor) and the matter was adjourned to September 13, 2016 for sentencing.

SEAN M. SKINNER, age 31, of Piffard was sentenced on a conviction of Assault in the Third Degree (Misdemeanor) to 3 years probation to include 144 hours community service. He was also ordered to pay a \$200 surcharge, a \$50 DNA fee, and an Order of Protection was issued for the victim.

ANTHONY C. VELASQUEZ, age 28, of Mt. Morris, charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to August 2, 2016. Bail was set at \$10,000.
