After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on October 3, 2017.

SAMMY L. BLYTHERS, JR., age 31, of Rochester pled guilty to Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (Misdemeanor) and the matter was adjourned to January 2, 2018 for sentencing.

CEARRA N. CAMPBELL, age 20, of Rochester pled guilty to Grand Larceny in the Fourth Degree (E Felony) and the matter was adjourned to December 19, 2017 for sentencing.

JOSEPH R. CUOZZO, III., age 35, of York was sentenced on a conviction of Grand Larceny in the Fourth Degree (E Felony) to 3 months intermittent incarceration and 5 years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee. An Order of Protection was issued for the victim.

SHELLY DUTTON, age 45, of Avon was sentenced on a violation of probation to continue probation with the addition of Drug Treatment Court.

JOSEPH A. FLETCHER, age 51, of Dansville, charged with Criminal Possession of a Weapon in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to December 19, 2017.

JUSTIN T. IKELER, age 33, of Dansville, convicted of Attempted Criminal Possession of a Weapon in the Third Degree (E Felony), appeared with his attorney and the matter was adjourned to October 10, 2017.

BALDEMAR MALDONADO, age 40, of Batavia, charged with Grand Larceny in the Fourth Degree (E Felony), Criminal Possession of Stolen Property in the Fourth Degree (E Felony), and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to December 19, 2017.

ADAM R. PETERSON, age 36, of Livonia, charged with Criminal Contempt in the First Degree (E Felony), Endangering the Welfare of a Child (Misdemeanor), and Harassment in the Second Degree, appeared with his attorney and the matter was adjourned to November 14, 2017.

SHAWN M. SCHLEDORN, age 40, of Dansville, charged with Driving While Ability Impaired by Drugs (D Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), and Failure to Keep Right, appeared with his attorney and the matter was adjourned to October 17, 2017.

NICHOLAS R. YOUNG, age 23, of West Sparta was charged with Burglary in the Second Degree (C Felony), Criminal Mischief in the Fourth Degree (Misdemeanor), and Petit Larceny (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 19, 2017. An Order of Protection was issued for the victim.

JASON L. ZIENKIEWICZ, age 33, of Rochester pled guilty to Driving While Intoxicated (E Felony) and the matter was adjourned to December 19, 2017 for sentencing.
