**After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on October 31, 2017.**

**A YOUTHFUL OFFENDER** appeared on a violation of probation and the matter was adjourned to November 14, 2017. He was remanded to the Livingston County Jail without bail.

**MATTHEW MCCLOSKEY**, age 28, formerly of Groveland Correctional Facility was charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 5, 2017.

**RYAN C. MCCOLLUMN**, age 36, of Livonia appeared on a violation of probation and the matter was adjourned to November 14, 2017. He was remanded to the Livingston County Jail without bail.

**ANTONIO PERDUE**, age 31, of Rochester pled guilty to Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and the matter was adjourned to January 2, 2018 for sentencing.

**MELWIN O. ROSARIO**, age 28, of Nunda, charged with Assault in the First Degree (B Felony), Assault in the Second Degree (D Felony), and Criminal Possession of a Weapon in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to December 11, 2017.

**EVERETT E. ROSS**, age 38, of Avon, charged with Burglary in the Third Degree (D Felony) and Petit Larceny, appeared with his attorney and the matter was adjourned to November 14, 2017.

**SHAWN M. SCHLEDORN**, age 40, of Dansville was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (misdemeanor) to time-served. He was also ordered to pay restitution.

**ERICA C. STEFANO**, age 36, of Piffard was sentenced on a conviction of Attempted Welfare Fraud in the Fourth Degree (Misdemeanor) to 3 years probation. She was also ordered to pay a \$200 surcharge, a \$50 DNA fee, and restitution.

**JESSICA WADDINGTON**, age 40, of Mt. Morris was sentenced on a conviction of Offering a False Instrument for Filing in the First Degree (E Felony) to 5 years probation. She was also ordered to pay restitution.

**DAVID A. YOUNG**, age 61, of Livonia was sentenced on a violation of probation to 1 ½ years in state prison plus 1 year post-release supervision. His probation was revoked.
