**After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on November 9, 2017.**

**JOHN T. ALLEN, II.**, age 45, of Fulton, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Aggravated Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), and Driving While Intoxicated (E Felony), appeared with his attorney and the matter was adjourned to November 30, 2017.

**CARLOS F. ARRIAGA**, age 38, of Dansville was sentenced on a conviction of Attempted Grand Larceny in the Fourth Degree (Misdemeanor) to 3 months incarceration and 3 years probation. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

**FERNANDO ALVARADO-PEREZ**, age 37, of Geneseo was sentenced on a conviction of Rape in the First Degree (B Felony) 20 years in state prison plus 20 years post-release supervision. He was also ordered to pay a \$1,000 Sex Offender registry fee, a \$325 surcharge, and a \$50 DNA fee. An 8 year Order of Protection was issued for the victim.

**JAHMAR T. BATTISTE**, age 28, of Troy was charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to November 30, 2017.

**SHARON L. DAVIS**, age 54, of Geneseo, charged with Driving with .18 of One Percent or More of Alcohol in Her Blood (D Felony), Driving While Intoxicated (D Felony), and Failure to Stop at a Stop Sign, appeared without her attorney and the matter was adjourned to November 30, 2017. Bail was continued at \$200,000.

**MICHAEL P. GORMEL**, age 39, of Lakeville was sentenced on a violation of probation to continue probation with the addition of Drug Treatment Court.

**ELBERT JACKSON, JR.**, age 55, of Rochester, charged with two counts of Aggravated Driving While Intoxicated with a Child (E Felony), Driving with .18 of One Percent or More of Alcohol in His Blood (Misdemeanor), Driving While Intoxicated (Misdemeanor), and Endangering the Welfare of a Child, appeared with his and the matter was adjourned to November 30, 2017.

**ZACHARY J. MARTIN**, age 23, of Caledonia pled guilty to Criminal Sale of a Controlled Substance in the Third Degree (B Felony) and the matter was adjourned to January 4, 2018 for sentencing. He was remanded to the Livingston County Jail without bail.

**JOHN MAYNARD**, age 26, of Geneseo was sentenced on a conviction of Burglary in the Third Degree (D Felony) to 1½ to 4½ years in state prison. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

**SHAHID SMITH**, age 35, formerly of Livingston Correctional Facility was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor) to 1 year in the Livingston County Jail. He was also ordered to pay a \$200 surcharge and a \$50 DNA fee.

**JEFFREY J. WALKER, JR.**, age 21, of Livonia pled guilty to Criminal Disposal of a Weapon (D Felony) and the matter was adjourned to January 11, 2018 for sentencing.

**AMANDA S. WILSON**, age 35, of Lakeville pled guilty to Attempted Promoting a Sexual Performance by a Child (E Felony) and the matter was adjourned to January 18, 2018 for sentencing.

**DANIEL D. WOOD**, age 50, of Conesus pled guilty to Attempted Grand Larceny in the Third Degree (E Felony) and a violation of probation and the matter was adjourned to January 4, 2018 for sentencing. He was remanded to the Livingston County Jail without bail.
