After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments (plus 1 sealed indictment) on the following individuals on November 15, 2017.

FORREST R. MCHENRY, age 44, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Uninspected Motor Vehicle, and Inadequate Splash Guards.

LANCE A. RILEY, age 38, of Dansville was charged with Rape in the Second Degree (D Felony), 4 counts of Rape in the Third Degree (E Felony), Criminal Sexual Act in the Third Degree (E Felony), Incest in the Second Degree (D Felony), 3 counts of Incest Third Degree (E Felony), and 4 counts of Endangering the Welfare of a Child (Misdemeanor).

MARJORIE A. HAZLETT, age 66, of Dansville was charged with Arson in the Third Degree (C Felony) and Criminal Mischief in the Second Degree (D Felony).

DELBERT R. CAPLINGER, JR., age 61, of Delevan was charged with Driving While Intoxicated (E Felony).

DURUNE L. HILL, age 39, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony).

EUGENE N. SMITH, age 68, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Leaving the Scene of a Property Damage Accident, and Failure to Stop at a Stop Sign.

After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals on October 18, 2017.

JAHMAR T. BATTISTE, age 28, of Troy was charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor).

CHAD D. MATTISON, age 41, of Dansville was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Ability Impaired (Misdemeanor), Operating a Motor Vehicle without an Ignition Interlock Device (Misdemeanor), and Inadequate Exhaust.
