**After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on January 4, 2018.**

**TRACY M. BABCOCK**, age 45, of Rochester, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Criminal Impersonation in the Second Degree (Misdemeanor), Operating a Motor Vehicle While Using Mobile Phone, Inadequate Tail Lights, and No Seatbelt, appeared with her attorney and the matter was adjourned to January 18, 2018.

**A YOUTHFUL OFFENDER** pled guilty to Burglary in the Third Degree (D Felony) and the matter was adjourned to March 1, 2018 for sentencing. He was remanded to the Livingston County Jail without bail.

**MARLIN L. CASH**, age 39, of Rochester appeared on a violation of probation and the matter was adjourned to January 18, 2018. He was remanded to the Livingston County Jail without bail.

**ASHLEY K. GRAUMANN**, age 34, of Avon was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Aggravated Driving with .18 of One Percent or More of Alcohol in Her Blood ((Misdemeanor), and Driving While Intoxicated (Misdemeanor). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to February 15, 2018. Her license was suspending pending prosecution and she was released on electronic home monitoring.

**DURUNE L. HILL**, age 39, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony). He was arraigned without an attorney, pled not guilty, and the matter was adjourned to January 11, 2018.

**ANDREW A. LEMMON, JR**, age 30, of Dansville was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) to 1 year in state prison plus 1 year post-release supervision. He was also ordered to pay a \$50 DNA fee and restitution.

**ZE HAO LIN**, age 22, of Brooklyn was sentenced on a conviction of Attempted Criminal Possession of Marihuana in the Second Degree (E Felony) to 30 days in jail and 5 years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**ZACHARY J. MARTIN**, age 24, of Caledonia was sentenced on a conviction of Criminal Sale of a Controlled Substance in the Third Degree (B Felony) to 1 year in state prison plus 1 year post-release supervision. He was also ordered to pay a \$50 DNA fee and restitution.

**RANDY L. SMITH** age 45, of Rochester, charged with 2 counts of Burglary in the Second Degree (C Felony), 2 counts of Grand Larceny in the Fourth Degree (E Felony), Criminal Mischief in the Fourth Degree (Misdemeanor), and 2 counts of Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to February 6, 2018 for a jury trial.

**DANIEL D. WOOD**, age 51, of Conesus was sentenced on a conviction of Attempted Grand Larceny in the Third Degree (E Felony) and a violation of probation to 1½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.
