**After presentation by Gregory J. McCaffrey, District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on January 23, 2018.**

**A YOUTHFUL OFFENDER**, charged with Burglary in the Third Degree (D Felony) and 3 counts of Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to February 6, 2018.

**ANTHONY CASSATA**, age 53, of Dansville, charged with Grand Larceny in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to February 20, 2018.

**JOSEPH A. FLETCHER**, age 51, of Dansville was sentenced on a conviction of Attempted Criminal Possession of a Weapon in the Third Degree (E Felony) to 1 month intermittent incarceration in the Livingston County Jail. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee. An Order of Protection was issued for the victim.

**ROSCOE J. HOWARD**, age 46, of Rochester was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) to 5 years probation. He was also ordered to pay an \$88 surcharge and a \$50 DNA fee.

**SEAN G. JOHNSTON**, age 49, of Leroy, charged with Criminal Sale Controlled Substance in the Third Degree (B Felony) and Criminal Possession Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to February 6, 2018 for hearings.

**SUSAN E. KING**, age 43, of Dansville, charged with Criminal Possession Controlled Substance Fifth Degree (D Felony) and Criminal Sale of a Controlled Substance in the Fifth Degree (D Felony), appeared with her attorney and the matter was adjourned to January 30, 2018.

**A YOUTHFUL OFFENDER** was sentenced on a conviction of Burglary in the Third Degree to 1 year incarceration in the Livingston County Jail. An Order of Protection was issued for the victim.

**MELWIN O. ROSARIO**, age 28, of Nunda was sentenced on a conviction of Attempted Assault in the First Degree (C Felony) to 10 years in state prison plus 5 years post-release supervision. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee. An Order of Protection was issued for the victim.

**EVERETT E. ROSS**, age 38, of Avon, charged with Burglary in the Third Degree (D Felony) and Petit Larceny, appeared with his attorney and the matter was adjourned to February 6, 2018.
