**After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on March 1, 2018.**

**A YOUTHFUL OFFENDER** was sentenced on a conviction of Burglary in the Third Degree (D Felony) to time-served and 5 years probation. He was also ordered to pay restitution and a \$325 surcharge. An Order of Protection was issued for the victim.

**DAWN ALLWOOD BOOP**, age 51, of Caledonia, convicted of Welfare Fraud in the Fifth Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to March 29, 2018.

**KASSIE L. BRAZIEL**, age 31, of Wayland appeared on a Violation of Probation and the matter was adjourned to March 8, 2018.

**CORY A. CURRY**, age 27, of Nunda appeared on a Violation of Probation and the matter was adjourned to March 8, 2018.

**DEREK J. GETMAN**, age 27, of Conesus, charged with Predatory Sexual Assault against a Child (A Felony), Criminal Sexual Act in the First Degree (B Felony), Incest in the First Degree (B Felony), and Endangering the Welfare of a Child (Misdemeanor), appeared with his attorney and the matter was adjourned to April 5, 2018.

**WILLIAM T. HAMILTON**, age 66, of Atlanta was charged with Criminal Sexual Act in the Third Degree (E Felony) and Forcible Touching (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to May 17, 2018. An Order of Protection was issued for each victim.

**AMBER E. WESTER**, age 28, of Rochester was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 128 hours community service and 5 years probation. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**KASCHEEN S. WILLIAMS**, age 19, of Rochester was charged with two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and Criminal Sale of a Controlled Substance in the Third Degree (B Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 12, 2018.
