After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on April 12, 2018.

SCOTT A. CASTLE, age 36, of Manchester, charged with Attempted Rape in the First Degree (C Felony), Attempted Criminal Sexual Act in the First Degree (C Felony), and Attempted Disseminating Indecent Material to Minors in the First Degree (E Felony), appeared with his attorney and the matter was adjourned to May 17, 2018.

WAYNE C. ENGLERT, age 58, of Dansville was charged with Sex Offender Failure to Register or Verify (E Felony.) He was arraigned with his attorney, pled not guilty, and the matter was adjourned to May 17, 2018.

CHRISTINE L. GOODMAN, age 46, of Geneva was charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony.) She was arraigned with her attorney, pled not guilty, and the matter was adjourned to June 14, 2018.

MIKEN M. PALMER, age 35, of Livonia was charged with two counts of Criminal Possession of a Weapon in the Third Degree (D Felony). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to June 7, 2018.

JAMES J. RIECHEL, age 41, of Leroy pled guilty to Driving While Intoxicated (E Felony) and the matter was adjourned to June 7, 2018. He was remanded to the Livingston County Jail without bail.

RYAN A. ROSS, age 21, of Bath pled guilty to Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor) and the matter was adjourned to June 7, 2018 for sentencing. He was remanded to the Livingston County Jail without bail.

RANDY L. SMITH age 45, of Rochester, charged with 2 counts of Burglary in the Second Degree (C Felony), 2 counts of Grand Larceny in the Fourth Degree (E Felony), Criminal Mischief in the Fourth Degree (Misdemeanor), and 2 counts of Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to May 30, 2018 for a hearing.

AUSTIN R. VAUGHAN, age 20, of Avon was sentenced on a conviction of Driving While Intoxicated (E Felony) and a violation of probation to 1 to 3 years in state prison. He was also ordered to pay a \$520 penalty assessment and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device.

KASCHEEN S. WILLIAMS, age 19, of Rochester pled guilty to Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and the matter was adjourned to June 14, 2018 for sentencing. He was remanded to the Livingston County Jail without bail.
