After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on June 5, 2018.

CHRISTOPHER W. CAMPBELL, age 37, of Mt. Morris, charged with Criminal Sale Controlled Substance in the Third Degree (B Felony) and Criminal Possession Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to July 31, 2018.

MELVIN A. CARTER, age 63, of Leicester was charged with Sex Offender Failure to Register or Verify (E Felony.) He was arraigned with his attorney, pled not guilty, and the matter was adjourned to July 31, 2018. Bail was continued at \$10,000.

DANIELLE S. DOWNS, age 35, of Rochester, charged with Criminal Possession of a Weapon in the Third Degree (D Felony), Unlawful Possession of Marijuana, and Speeding, appeared with his attorney and the matter was adjourned to July 3, 2018.

REBECCA A. GARRISON, age 28, of Dansville was sentenced on a conviction of Attempted Falsifying Business Records in the First Degree (Misdemeanor) to 256 hours community service and 3 years probation. She was also ordered to pay a \$200 surcharge and a \$50 DNA fee.

JANELLE M. JONES, age 27, of Livonia, charged with Grand Larceny in the Third Degree (D Felony), 20 counts of Grand Larceny in the Fourth Degree (E Felony), and a violation of probation, appeared with her attorney and the matter was adjourned to June 19, 2018.

DEBORA A. KRUEGER, age 44, of Dansville pled guilty to Criminal Sale of a Controlled Substance in the Fourth Degree (C Felony) and the matter was adjourned to July 31, 2018 for sentencing.

DONNA J. MADORRAN, age 61, of Geneseo was sentenced on a conviction of Driving While Impaired by Drugs (E Felony) to 5 years probation. She was also ordered to pay a \$2,000 fine, a \$520 surcharge and a \$50 DNA fee. Her license was revoked with a requirement to install an Ignition Interlock Device and she was ordered to attend the DWI Victim Impact Panel.

JORDAN S. VAN HOUTER, age 22, of Rochester, charged with Burglary in the Third Degree (D Felony), Criminal Possession of Stolen Property Third Degree (D Felony), Criminal Mischief in the Fourth Degree (Misdemeanor) and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to July 31, 2018.

DAWN M. WILSON, age 53, of Dansville, charged with Falsifying Business Records in the First Degree (E Felony) and Conspiracy in the Fifth Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to June 19, 2018.
