After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments (plus 2 sealed indictments) on the following individuals on June 6, 2018.

JAMES K. SMITH, age 33, of Rochester was charged with Forgery in the Second Degree (D Felony) and Grand Larceny in the Fourth Degree (E Felony)

CARRIE A. YOUNG, age 42, of Stanley was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Aggravated Driving with .18 of One Percent of Alcohol or More in Her Blood (E Felony), Driving While Intoxicated (E Felony), Following Too Closely, and Possession of an Alcoholic Beverage in a Motor Vehicle.

KEVIN W. LORKA, age 61, of Cheektowaga was charged with Burglary in the Second Degree (C Felony), 2 counts of Attempted Burglary in the Second Degree (D Felony), and Criminal Mischief in the Fourth Degree (Misdemeanor).

DARIEN M. RAFORTH, age 52, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Speed in Zone.

After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals on May 23, 2018.

JEFFREY L. HAYES, age 53, of Henrietta was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Inadequate Exhaust.

MELVIN A. CARTER, age 73, of Leicester was charged with Sexual Offender Failure to Register or Verify (E Felony).

SABOOR A. MOHMAND, age 39, of Pennsylvania was charged with Driving While Ability Impaired by Drugs (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), and Failure to Keep Right.

JOHN R. LITOLFF, age 33, of Livonia was charged with Criminal Contempt in the First Degree (E Felony), 14 counts of Aggravated Family Offense (E Felony), 5 counts of Criminal Contempt Second Degree (Misdemeanor), 8 counts of Attempted Criminal Contempt Second Degree (Misdemeanor), 3 counts of Criminal Mischief in the Fourth Degree (Misdemeanor), Obstruction of Governmental Administration Second Degree, and Harassment in the Second Degree.

DEREK J. GETMAN, age 27, of Conesus was charged with Predatory Sexual Assault Against a Child (A Felony) and Course of Sexual Conduct Against a Child in the First Degree (B Felony).
