After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on June 19, 2018.

JANELLE M. JONES, age 27, of Livonia, charged with Grand Larceny in the Third Degree (D Felony), 20 counts of Grand Larceny in the Fourth Degree (E Felony), and a violation of probation, appeared with her attorney and the matter was adjourned to July 24, 2018.

RONIKA S. JONES, age 34, of Syracuse was sentenced on a conviction of Aggravated Driving While Intoxicated with a Child (E Felony) to 4 months intermittent incarceration and 5 years probation. She was also ordered to pay a \$2000 fine, a \$520 surcharge, and a \$50 DNA fee. Her license was revoked with a requirement to install an Ignition Interlock Device and she was ordered to attend the DWI Victim Impact Panel.

RUSSELL H. MAURER, age 61, of Livonia, charged with Attempted Burglary in the Third Degree (E Felony), Petit Larceny (Misdemeanor), and Criminal Contempt in the Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to July 3, 2018.

VALERIE B. MCCARTHY, age 57, of Canton was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 5 years probation to include 300 hours community service. She was also ordered to pay a \$325 penalty assessment and a \$50 DNA fee.

SABOOR A. MOHMAND, age 39, of Pennsylvania was charged with Driving While Ability Impaired by Drugs (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), and Failure to Keep Right. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to July 24, 2018.

KAYANA A. SALMON, age 23, of Rochester, charged with Criminal Possession of Stolen Property Third Degree (D Felony), Criminal Possession of Stolen Property in the Fourth Degree (E Felony), Aggravated Driving While Intoxicated with a Child (E Felony), Driving While Impaired by Drugs (Misdemeanor), Unlawful Fleeing a Police Officer in the Third Degree (Misdemeanor), Unauthorized Use of a Motor Vehicle in the Second Degree (E Felony), Criminal Impersonation in the Second Degree (Misdemeanor), Endangering the Welfare of a Child (Misdemeanor), Aggravated Unlicensed Operation of a Motor Vehicle in the Third Degree (Misdemeanor), Reckless Driving, 2 counts of Speeding, and 2 counts of Failure to Stop at a Stop Sign, appeared with her attorney and the matter was adjourned to September 4, 2018.

RAUL SANTIAGO, age 38, of Geneseo was charged with Bribe Receiving in the Third Degree (D Felony), Promoting Prison Contraband in the Second Degree (Misdemeanor), and Official Misconduct (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to August 14, 2018.

DONNA J. SHELTON, age 44, of Wyoming was charged with Offering a False Instrument for Filing in the First Degree (E Felony), Falsifying Business Records in the First Degree (E Felony), Welfare Fraud in the Fourth Degree (E Felony), Grand Larceny in the Fourth Degree (E Felony). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to July 24, 2018.

JEFFREY M. SMITH, age 42, of Avon was sentenced on a conviction of Criminal Possession of a Weapon in the Fourth Degree (Misdemeanor) to 3 years probation. He was also ordered to pay a \$200 surcharge and a \$50 DNA fee.

ALAN J. STEFANI, age 23, of Pennsylvania, charged with Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), appeared with his attorney and the matter was adjourned for hearings.

JOHN W. WASHBURN, III., age 30, of Rochester, charged with Robbery in the Third Degree and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned for hearings.

KYLE J. WEBSTER, age 21, of Mt. Morris, charged with 2 counts of Possessing a Sexual Performance by a Child (E Felony) and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to July 3, 2018.

DAWN M. WILSON, age 53, of Dansville, pled guilty to Attempted Falsifying Business Records in the First Degree (Misdemeanor) and the matter was adjourned to August 14, 2018.
