DA NEWSLETTER ~ AUGUST 14, 2018

After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on August 14, 2018.

CHRISTOPHER W. CAMPBELL, age 37, of Mt. Morris, charged with Criminal Sale Controlled Substance in the Third Degree (B Felony) and Criminal Possession Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to August 21, 2018.

MELVIN A. CARTER, age 73, of Leicester was sentenced on a conviction of Sex Offender Failure to Register or Verify (E Felony) to 4 months intermittent incarceration. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

DANIEL J. FERRARO-GIBBS, age 35, of Spencerport, convicted of Criminal Contempt in the First Degree (E Felony), appeared with his attorney and the matter was adjourned to September 11, 2018 for sentencing.

ROBERT J. FISHER, age 71, of Conesus was sentenced on a violation of probation to 1 year in the Livingston County Jail.

RYAN A. GARRISON, age 23, of Atlanta was sentenced on a conviction of Attempted Criminal Possession of Precursors of Methamphetamine (Misdemeanor) to 4 months intermittent incarceration and 3 years probation. He was also ordered to pay a \$200 surcharge and a \$50 DNA fee.

JUSTIN M. GLEDHILL, age 21, of Mt. Morris pled guilty to Attempted Grand Larceny in the Fourth Degree (Misdemeanor) and the matter was adjourned to October 9, 2018.

NATHAN J. GONZALES, age 30, of Wayland was sentenced on a conviction of Attempted Falsifying Business Records in the First Degree (Misdemeanor) to 3 years probation. He was also ordered to pay a \$200 surcharge and a \$50 DNA fee.

BROCK M. HYDE, age 36, of Nunda was sentenced on a conviction of Reckless Assault of a Child (D Felony) and Assault in the Second Degree (D Felony) to 12 years in state prison plus 10 years post-release supervision as a second violent felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

KENNETH T. MOUNTZOUROS, age 60, of Conesus, charged with Sexual Abuse in the First Degree (D Felony), 2 counts of Forcible Touching (Misdemeanor), 2 counts of Endangering the Welfare of a Child (Misdemeanor), and Sexual Abuse in the Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to September 25, 2018.

HOLLY M. ORMAN, age 42, of Avon was charged with Rape in the Second Degree (D Felony), Criminal Sexual Act in the Second Degree (D Felony), Sexual Misconduct (Misdemeanor), and Endangering the Welfare of a Child (Misdemeanor). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to October 9, 2018.

LANCE A. RILEY, age 38, of Dansville was sentenced on a conviction of Rape in the Second Degree (D Felony) and Criminal Sexual Act in the Third Degree (E Felony) to 10 years in state prison plus 10 years post-release supervision to include Sex Offender Registration. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, a \$1000 Sex Offender Registry Fee. An Order of Protection was issued for the victim.
