**DA NEWSLETTER ~ OCTOBER 2, 2018**

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on October 2, 2018.

**BAILEE J. BORDEN**, age 22, of Nunda, charged with Criminal Sale Controlled Substance in the Third Degree (B Felony) and Criminal Possession Controlled Substance in the Third Degree (B Felony), appeared with her attorney and the matter was adjourned to October 16, 2018.

**CHRISTOPHER W. CAMPBELL**, age 37, of Mt. Morris, charged with Criminal Sale Controlled Substance in the Third Degree (B Felony) and Criminal Possession Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to October 9, 2018.

**ANTHONY CASSATA**, age 54, of Dansville, convicted of Attempted Grand Larceny in the Third Degree (E Felony), appeared with his attorney and the matter was adjourned October 16, 2018 for sentencing.

**JOSE L. CRUZ-SOTO**, age 39, of Mt. Morris, charged with 3 counts of Criminal Sale Controlled Substance in the Third Degree (B Felony) and 3 counts of Criminal Possession Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to October 16, 2018 for hearings.

**WAYNE G. JOHNSON**, age 34, of Dansville, convicted of Criminal Sale of a Controlled Substance in the Fifth Degree (D Felony), appeared with his attorney and the matter was adjourned to October 16, 2018 for sentencing.

**RUSSELL H. MAURER**, age 62, of Livonia, convicted of Attempted Burglary in the Third Degree (E Felony), appeared with his attorney and the matter was adjourned to October 9, 2018 for sentencing.

**FRANK J. MULLEY**, age 54, of Leicester was sentenced on a conviction of Driving While Intoxicated (E Felony) to 1 to 3 years in state prison. He was also ordered to pay a \$2000 fine, a \$520 penalty assessment, and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device.

**ANTONIO M. PADRON-RODRIGUEZ, JR.**, age 31, of Mt. Morris was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) to 1 ½ years in state prison plus 1 year post-release supervision. He was also ordered to pay a \$325 penalty assessment and a \$50 DNA fee. His license was also suspended.

**DYLAN J. ROBBINS**, age 27, of Pennsylvania was charged with two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), Criminal Possession Weapon in the Fourth Degree (Misdemeanor), and Inadequate Exhaust. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to November 27, 2018.

**DAVID M. SKINNER**, age 57, of Livonia, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Inadequate Exhaust, appeared with his attorney and the matter was adjourned to October 16, 2018.

**JAMES W. STINER**, age 38, of Pennsylvania was sentenced on a conviction of 2 counts of Grand Larceny in the Fourth Degree (E Felony) and Attempted Burglary in the Third Degree (E Felony) to 6 months incarceration and 5 years probation. He was also ordered to pay restitution, surcharges, and DNA fees.
