## DA NEWSLETTER ~ NOVEMBER 8, 2018

After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on November 8, 2018.

**ADAM E. BORTLE**, age 35, of Dansville, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), appeared with his attorney and the matter was adjourned to November 15, 2018.

**SANDRA N. BROWN**, age 41, of North Carolina, charged with Menacing a Police Officer (D Felony) and Conspiracy in the Fifth Degree (Misdemeanor), appeared with her attorney and the matter was adjourned for possible hearings.

**FREDERICK R. CAVALLARO**, age 45, of Lima was sentenced on a conviction of Driving While Intoxicated (E Felony) to 16 weekends incarceration and 5 years probation. He was also ordered to pay a \$520 surcharge and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device.

**SCOTT T. FIOREDELISO**, age 28, of Webster was charged with four counts of Attempted Disseminating Indecent Material to Minors First Degree (E Felony) and Endangering Welfare of a Minor. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 24, 2019.

**DEREK J. GETMAN**, age 28, of Conesus, charged with Predatory Sexual Assault against a Child (A Felony), Course of Sexual Conduct Against a Child in the First Degree (B Felony), and Endangering the Welfare of a Child (Misdemeanor), appeared with his attorney and the matter was adjourned to November 21, 2018.

**SADIE HARWOOD**, age 23, of Groveland, charged with two counts of Assault in the First Degree (B Felony), appeared with her attorney and the matter was adjourned for further proceedings.

**JOHN R. LITOLFF**, age 33, of Livonia was sentenced on a conviction of Criminal Contempt in the First Degree (E Felony) to 1 ½ to 4 years in state prison. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and an Order of Protection was issued for the victim.

**BOBBIE MARRERO**, age 46, of Mt. Morris was sentenced on a conviction of Criminal Possession Controlled Substance in the Third Degree (B Felony) to 5 years in state prison plus 2 years post-release supervision. She was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

**CHRISTOPHER J. MATUSAK**, age 35, of Henrietta, charged with Burglary in the Third Degree (D Felony), Criminal Mischief in the Fourth Degree (Misdemeanor), and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to November 15, 2018.

**JIMMY MOLINA**, age 47, formerly of Groveland Correctional Facility was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 1 ½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**DAVID A. PFUNTER**, age 65, of Dansville, charged with Driving While Intoxicated (E Felony) and Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), appeared with his attorney and the matter was adjourned to December 13, 2018.

**KEVIN G. RIGDON**, age 33, of Dansville pled guilty to Robbery in the Second Degree (C Felony) and the matter was adjourned to January 3, 2019 for sentencing.

**LEO F. SCHLEDORN**, age 30, of Dansville, charged with Sexual Offender Failure to Register or Verify (E Felony), 3 counts of Predatory Sexual Assault Against a Child (A Felony), Course of Sexual Conduct Against a Child in the First Degree (B Felony), Sexual Abuse in the First Degree (D Felony), 2 counts of Criminal Sexual Act in the First Degree (B Felony) and 3 counts of Endangering the Welfare of a Child (Misdemeanor), appeared with his attorney and the matter was adjourned to December 6, 2018.

**MICHAEL G. SWICK**, age 29, of Mt. Morris, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Inadequate Exhaust, appeared with his attorney and the matter was adjourned to December 13, 2018. Bail was set at \$10,000.

**JAMES A. THADDIES**, age 41, of Elmira, charged with Criminal Possession Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Possession Controlled Substance in the Seventh Degree (Misdemeanor), appeared without an attorney and the matter was adjourned to November 15, 2018.

**ULISES VALENTIN**, age 43, of Mt. Morris was sentenced on a conviction of Criminal Possession Controlled Substance in the Third Degree (B Felony) to 1 year in state prison plus 1 year post-release supervision. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and \$100 restitution.

**RYAN T. WICKER**, age 22, of Dansville was sentenced on a conviction of Attempted Criminal Possession of a Weapon in the Third Degree (E Felony) to 1 ½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and an Order of Protection was issued for the victim.
