**DA NEWSLETTER ~ NOVEMBER 15, 2018**

After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on November 15, 2018.

**ADAME E. BORTLE**, age 35, of Dansville was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) to 1 year in the Livingston County Jail. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**DONALD J. CHAPMAN**, age 56, of Mt. Morris was sentenced on a conviction of Driving While Intoxicated (E Felony) to 16 weekends incarceration and 5 years probation to include electronic home monitoring. He was also ordered to pay a \$520 surcharge and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device.

**TIMOTHY GREEN, JR.**, age 30, of Rochester, convicted of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned to February 14, 2019.

**OWEN R. LOWRY**, age 31, of Geneseo appeared on a Violation of Probation and the matter was adjourned to December 6, 2018. He was remanded to the Livingston County Jail without bail.

**WILLIAM A. MARTIN, II.**, age 50, formerly of Livingston Correctional Facility was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 1 ½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**CHRISTOPHER J. MATUSAK**, age 35, of Henrietta, charged with Burglary in the Third Degree (D Felony), Criminal Mischief in the Fourth Degree (Misdemeanor), and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to December 13, 2018.

**ARON E. MCCALLUM**, age 30, of Springwater was sentenced on a Violation of Probation to 1 to 3 years in state prison.

**JASON A. QUICK**, age 36, of Nunda pled guilty to Criminal Possession Marihuana in the Third Degree (E Felony) and the matter was adjourned to February 14, 2019.

**DARIEN M. RAFORTH**, age 52, of Rochester was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) to 16 weekends incarceration and 5 years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**EVYN ZENNER**, age 22, of Avon was charged with Burglary in the Third Degree (D Felony) and Petit Larceny (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 17, 2019.
