DA NEWSLETTER ~ NOVEMBER 27, 2018

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on November 27, 2018.

LUKE M. GALLAGHER, age 21, of Elmira was charged with Criminal Possession of Marihuana in the Second Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 14, 2019. Bail was set at \$5000.

JOSHUA A. GANG, age 35, formerly of Groveland Correctional Facility, charged with Promoting Prison Contraband in the First Degree (D Felony), appeared with his attorney and the matter was adjourned for trial.

DAVID M. MAIN, age 43, of Nunda was charged with Grand Larceny in the Fourth Degree (E Felony) and Making a Punishable False Written Statement (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 28, 2019. Bail was set at \$1000.

SIMEON A. MARSHALL, age 20, of Syracuse pled guilty to Robbery in the Third Degree (D Felony) and the matter was adjourned to February 25, 2019 for sentencing.

ROBERT J. MILLER, age 47, of Pennsylvania, charged with Driving While Intoxicated (E Felony), Speeding, and No Seatbelt, appeared with his attorney and the matter was adjourned to January 7, 2019.

KENNETH T. MOUNTZOUROS, age 60, of Conesus, charged with Sexual Abuse in the First Degree (D Felony), 2 counts of Forcible Touching (Misdemeanor), 2 counts of Endangering the Welfare of a Child (Misdemeanor), and Sexual Abuse in the Second Degree (Misdemeanor), appeared with his attorney and the matter was adjourned for trial.

KEVIN SARAUW, age 23, formerly of Livingston Correctional Facility pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to January 28, 2019 for sentencing.

RODNEY R. SPARROW, age 50, formerly of Groveland Correctional Facility pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to January 28, 2019 for sentencing.

JORDAN S. VAN HOUTER, age 23, of Rochester was sentenced on a conviction of Burglary in the Third Degree (D Felony) and Criminal Mischief in the Third Degree (E Felony) to two concurrent terms of one to three years in state prison. He was also ordered to pay a \$325 surcharge and \$50 DNA fee on each conviction and restitution of \$441 on the Burglary Third Degree conviction and \$825 on the Criminal Mischief Third conviction.
