DA NEWSLETTER ~ DECEMBER 4, 2018

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on December 4, 2018:

A YOUTHFUL OFFENDER admitted a violation of probation and the matter was adjourned to January 29, 2019 for sentencing.

JAMES BALTAZAR, age 29, formerly of Livingston Correctional Facility was sentenced on a conviction of Assault in the Second Degree (D Felony) to 5 years in state prison plus 5 years post-release supervision. He was also ordered to pay a \$325 penalty assessment and a \$50 DNA fee.

JOSEPH I. BLIZZARD, age 31, of Dansville was charged with Criminal Possession of Weapon Second Degree (C Felony), Criminal Sale of a Firearm Third Degree (D Felony), Criminal Possession of a Firearm (E Felony), and Grand Larceny in the Fourth Degree (E Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 15, 2019.

SHANNON M. DAVIDSON, age 42, of Mt. Morris appeared on a violation of probation and the matter was adjourned to December 18, 2018.

SHERRY A. NICHOLS, age 44, of Mt. Morris pled guilty to Criminal Sale Controlled Substance in the Third Degree (B Felony) and the matter was adjourned to December 6, 2018 for sentencing.

ROBERT L. TURNER, age 62, of Rochester pled guilty to Attempted Criminal Possession Forged Instrument in the Second Degree (E Felony) and the matter was adjourned to January 29, 2019 for sentencing.

JOHN W. WASHBURN, III., age 31, of Rochester was sentenced on a conviction of Robbery in the Third Degree (D Felony) to 1 ½ to 4 ½ year in state prison. He was also ordered to pay a \$325 penalty assessment, a \$50 DNA fee, and restitution. An Order of Protection was issued for the victim.

CURTIS M. WELCH, age 29, of Rochester was charged with Grand Larceny in the Third Degree (D Felony) and Falsifying Business Records First Degree (E Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to December 18, 2018.

NICK J. WILLIAMS, age 36, of Leicester was charged with Aggravated Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Operating a Motor Vehicle without an Ignition Interlock Device (Misdemeanor), and Leaving the Scene of a Property Damage Accident. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to January 8, 2019.
