**DA NEWSLETTER – JANUARY 24, 2019**

After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on January 24, 2019.

**DAVID L. HEATH**, age 29, of Rochester was sentenced on a conviction of Attempted Criminal Possession of a Controlled Substance in the Fourth Degree (D Felony) to two and one-half years in state prison plus two years post-release supervision. He was also ordered to pay a \$325 penalty assessment and a \$50 DNA fee.

**LEWIS E. HENRY, JR.**, age 46, of Mt. Morris, charged with Aggravated Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), and Failure to Keep Right, appeared with his attorney and the matter was adjourned to February 14, 2019.

**BERNARD D. O'GRADY**, age 21, of Bloomfield was sentenced on a conviction of Grand Larceny in the Fourth Degree (E Felony) to time-served and five years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**MICHAEL G. SWICK**, age 29, of Mt. Morris, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Inadequate Exhaust, appeared with his attorney and the matter was adjourned to February 25, 2019 for a jury trial.

**After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals (along with 2 sealed indictments) on January 9, 2019 and January 24, 2019.**

**CHARLES MACK**, age 47, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Speeding.

**KRISTOPHER H. EDELMAN**, age 28, of Rochester was charged with Aggravated Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the Third Degree (misdemeanor), and Speeding.

**MARK C. HARRINGTON**, age 51, of Livonia was charged with six counts of Predatory Sexual Assault Against a Child (Class A-II Felony), Sexual Abuse in the First Degree (D Felony), and Attempted Criminal Sexual Act in the First Degree (D Felony.)
