## **DA NEWSLETTER – JANUARY 29, 2019**

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on January 29, 2019.

**A YOUTHFUL OFFENDER** appeared on a violation of probation and the matter was adjourned to February 19, 2019 for sentencing.

**JOSEPH I. BLIZZARD**, age 32, of Dansville, charged with Criminal Possession of a Weapon in the Second Degree (C Felony), Criminal Sale of a Firearm in the Third Degree (D Felony), Criminal Possession of a Firearm (E Felony), and Grand Larceny in the Fourth Degree (E Felony), appeared with his attorney and the matter was adjourned to February 26, 2019.

**ARTHUR E. COLES**, age 28, of Canandaigua, charged with Driving While Intoxicated (E Felony), Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), Resisting Arrest, and Throwing Refuse on Highway, appeared with his attorney and the matter was adjourned to February 19, 2019.

**DAVID W. DALE**, age 32, of Mt. Morris pled guilty to Sex Offender Failure to Register or Verify (E Felony) and the matter was adjourned to March 26, 2019 for sentencing.

**NICHOLAS J. DISALVO**, age 34, of Mt. Morris appeared on a violation of probation and the matter was adjourned to February 19, 2019.

**DAVID M. HAWKES, JR.**, age 20, of Syracuse pled guilty to Attempted Robbery in the Second Degree (D Felony) and the matter was adjourned to March 26, 2019 for sentencing. He was remanded to the Livingston County Jail without bail.

**DAVID M. MAIN**, age 43, of Nunda pled guilty to Grand Larceny in the Fourth Degree (E Felony) and the matter was adjourned to April 30, 2019 for sentencing.

**HOLLY M. ORMAN**, age 42, of Avon was sentenced on a conviction of Sexual Misconduct (Misdemeanor) to six years probation. She is also required to register as a Sex Offender and pay a \$1000 fee. She is also order to pay a surcharge and a \$50 DNA fee. An Order of Protection was issued for the victim.

**SHERYL A. PALERMO**, age 51, of Tonawanda was sentenced on a conviction of Driving While Intoxicated (D Felony) to 2 to 6 years in state prison. She was also ordered to pay a \$520 surcharge and a \$50 DNA fee. Her license was revoked with a requirement to install an Ignition Interlock Device.

**RYAN W. PRIVETTS**, age 30, of Elmira, charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to February 13, 2019.

**KAYANA A. SALMON**, age 23, of Rochester was sentenced on a conviction of Attempted Criminal Possession of Stolen Property Third Degree (E Felony) and Aggravated Driving While Intoxicated with a Child (E Felony) to 1 to 3 years in state prison. She was also ordered to pay a \$520 surcharge and a \$50 DNA fee. Her license was revoked with a requirement to install an Ignition Interlock Device.

**KEVIN SARAUW**, age 23, formerly of Livingston Correctional Facility was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 1½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**CHRISTINA D. SCHULTZ**, age 42, of Geneseo was sentenced on a violation of probation to one year in the Livingston County Jail.

**KENNETH G. SCINTA, JR.**, age 48, of Honeoye, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Ability Impaired by the Combined Influence of Drugs or of Alcohol and any Drug or Drugs (Misdemeanor), and Failure to Dim Headlights, appeared with his attorney and the matter was adjourned to February 26, 2019.

**RAYMOND L. SCOTT**, age 46, of Dansville, charged with Sexual Offender Failure to Register or Verify (E Felony), appeared with his attorney and the matter was adjourned to February 19, 2019.

**DAVID M. SKINNER**, age 57, of Livonia was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) to 4 months intermittent incarceration and 5 years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**RODNEY R. SPARROW**, age 50, formerly of Groveland Correctional Facility was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 1½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**ROBERT L. TURNER**, age 62, of Rochester was sentenced on a conviction of Attempted Criminal Possession Forged Instrument in the Second Degree (E Felony) to 1½ to 3 years in state prison. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**SCOTT M. WOOD**, age 35, of Mt. Morris, charged with Driving While Intoxicated (E Felony), Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), and Crossing Hazardous Markings, appeared with his attorney and the matter was adjourned to February 19, 2019.
