**DA NEWSLETTER – FEBRUARY 26, 2019**

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on February 26, 2019.

**JOSEPH I. BLIZZARD**, age 32, of Dansville, charged with Criminal Possession of a Weapon in the Second Degree (C Felony), Criminal Sale of a Firearm in the Third Degree (D Felony), Criminal Possession of a Firearm (E Felony), and Grand Larceny in the Fourth Degree (E Felony), appeared with his attorney and the matter was adjourned to April 9, 2019 for hearings.

**JACOB BRIONES**, age 26, formerly of Groveland Correctional Facility was charged with Promoting Prison Contraband in the First Degree (D Felony). He was arraigned with his attorney, plead not guilty, and the matter was adjourned to March 26, 2019.

**JASON P. CANAAN**, age 23, of Piffard was sentenced on a conviction of Possessing an Obscene Sexual Performance by a Child (E Felony) to two months intermittent incarceration and ten years probation to include NYS Sex Offender Registration. He was also order to pay a \$325 surcharge, a \$50 DNA fee, and a \$1,000 sex offender fee.

**KIMBERLY DELAVERGNE**, age 43, of Mt. Morris, convicted of Grand Larceny in the Third Degree (D Felony), appeared with her attorney and the matter was adjourned to March 26, 2019.

**CARLOS DIAZ-SILVA**, age 35, of Mt. Morris was charged with two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony). He was arraigned with his attorney, plead not guilty, and the matter was adjourned to March 12, 2019.

**NICHOLAS J. DISALVO**, age 35, of Mt. Morris appeared on a violation of probation and the matter was adjourned to March 5, 2019.

**KASHAUNA ELLIS**, age 28, of Schenectady was sentenced on a conviction of Promoting Prison Contraband in the First Degree (D Felony) to time-served and five years probation. She is also order to pay a \$325 surcharge and a \$50 DNA fee.

**RYAN P. HORAN**, age 21, of Lakeville was charged with Possessing a Sexual Performance by a Child (E Felony). He was arraigned with his attorney, plead not guilty, and the matter was adjourned to April 23, 2019.

**WILLIAM W. PRITCHARD**, age 38, of Canaseraga, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving with .08 of One Percent or More of Alcohol in His Blood (Misdemeanor), Driving While Intoxicated (Misdemeanor), appeared with his attorney and the matter was adjourned to April 2, 2019 for hearings.

**RYAN W. PRIVETTS**, age 30, of Elmira was sentenced on a conviction of Attempted Criminal Possession of a Controlled Substance in the Third Degree (C Felony) to one year in state prison plus two years post-release supervision. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**NICHOLAS P. SADWICK**, age 32, of Rochester was sentenced on a conviction of Driving While Intoxicated (D Felony) to five years probation. He was also ordered to pay a \$520 surcharge, a \$50 DNA fee, a \$1,000 fine, and his license was revoked with a requirement to install an Ignition Interlock Device.

**KENNETH G. SCINTA, JR.**, age 48, of Honeoye, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Ability Impaired by the Combined Influence of Drugs or of Alcohol and any Drug or Drugs (Misdemeanor), and Failure to Dim Headlights, appeared with his attorney and the matter was adjourned to March 26, 2019 for hearings.

**A YOUTHFUL OFFENDER** appeared on a violation of probation and the matter was adjourned to March 12, 2019.

**ANTHONY J. SPEARANCE**, of Mt. Morris appeared on a violation of probation and the matter was adjourned to March 12, 2019.

**DEAN STEINER**, age 50, of Livonia, charged with two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), three counts of Criminal Possession of a Weapon in the Fourth Degree (Misdemeanor), and two counts of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), appeared with his attorney and the matter was adjourned for hearings.

**A YOUTHFUL OFFENDER** was charged with Rape in the Second Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 23, 2019. An Order of Protection was issued for the victim.

**CURTIS M. WELCH**, age 29, of Rochester, charged with Grand Larceny in the Third Degree (D Felony) and Falsifying Business Records in the First Degree (E Felony), appeared with his attorney and the matter was adjourned to March 12, 2019.
