DA NEWSLETTER – MARCH 28, 2019

After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on March 28, 2019.

ZACHERY A. BISHOP, age 20, of Piffard was charged with two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), two counts of Grand Larceny in the Fourth Degree (E Felony), and Endangering the Welfare of a Child (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 18, 2019.

KELVIN A. DELGADO, age 29, of Rochester was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 25, 2019.

DANIEL T. FLYNN, age 35, of Dansville was charged with Grand Larceny in the Third Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), Unauthorized Use of a Motor Vehicle in the Second Degree (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (E Felony), Leaving the Scene of a Property Damage Accident, and Refusal to Take Breath Test. He was arraigned with his attorney, pled not guilty, and the matter was adjourned to May 2, 2019.

JEAN M. LEVEY, age 61, of Lakeville was sentenced on a violation probation to continue probation with the addition of Drug Treatment Court.

NATHANIEL POUNDS, age 63, of Rochester was charged with Criminal Possession of a Forged Instrument in the Second Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 9, 2019.

NITASHIA L. ROBB, age 28, of Bath was sentenced on a conviction of Tampering with Physical Evidence (E Felony) to one to three years in state prison. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

VERNARDO V. TAITE, age 35, formerly of Groveland Correctional Facility pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to May 23, 2019 for sentencing.

JASON F. TEMELKOWSKI, age 37, Rochester was charged with Identity Theft in the First Degree (D Felony) and Grand Larceny in the Third Degree (D Felony). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to April 23, 2019.

JAMES A. THADDIES, age 41, of Elmira pled guilty to Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and the matter was adjourned to May 30, 2019 for sentencing.
