## **DA NEWSLETTER – APRIL 4, 2019**

After presentation by Victor D. Rowcliffe, First Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on April 4, 2019.

**SANDRA N. BROWN**, age 41, of North Carolina was sentenced on a conviction of Menacing a Police Officer (D Felony) to three years in state prison plus one and one-half years post-release supervision. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**CASSANDRA L. CANSDALE**, age 33, of Wayland was charged with Criminal Possession of a Forged Instrument in the First Degree (C Felony), Making a Punishable False Written Statement (Misdemeanor), and Falsely Reporting an Incident in the Third Degree (Misdemeanor). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to April 25, 2019. Bail was set at \$2,500.

**AMBER ELLIS**, age 32, of Nunda appeared on a Violation of Probation and the matter was adjourned to April 18, 2019. She was remanded to the Livingston County Jail without bail.

**DEREK J. GETMAN**, age 28, of Sparta was sentenced on a conviction of Criminal Sexual Act in the First Degree (B Felony) to 13 years in state prison plus 25 years post-release supervision to include NYS Sex Offender Registration. He was also order to pay a \$325 surcharge, a \$50 DNA fee, and a \$1,000 supplemental sex offender fee. An Order of Protection was issued for the victim.

**DAVID A. PFUNTNER**, age 65, of Dansville was sentenced on a conviction of Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony) to six months incarceration in the Livingston County Jail and five years probation to include electronic home monitoring. He was also ordered to pay a \$520 surcharge and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device.

**BRADLEE R. REDMAN**, age 26, of Dansville pled guilty to Rape in the Second Degree (D Felony) and the matter was adjourned to May 30, 2019 for sentencing. He was remanded to the Livingston County Jail without bail.

**LEO F. SCHLEDORN**, age 30, of Dansville, charged with three counts of Predatory Sexual Assault Against a Child (A Felony) and Use of a Child in a Sexual Performance (C Felony), appeared with his attorney and the matter was adjourned to May 2, 2019.

**TYRIK STYLES**, age 30, formerly of Groveland Correctional Facility pled guilty to Attempted Promoting Prison Contraband in the First Degree (E Felony) and the matter was adjourned to May 23, 2019 for sentencing.

**RONALD L. WILLIAMS**, age 29, formerly of Livingston Correctional Facility was charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to May 30, 2019.

**AMANDA S. WILSON**, age 37, of Lakeville was charged with Sex Offender Failure to Register or Verify (E Felony). She was arraigned with her attorney, pled not guilty, and the matter was adjourned to May 2, 2019.
