DA NEWSLETTER – APRIL 23, 2019

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on April 23, 2019.

BAILEE J. BORDEN, age 23, of Nunda, convicted of Criminal Possession of a Controlled Substance in the Third Degree (B Felony), appeared with her attorney and the matter was adjourned to May 21, 2019.

JACOB BRIONES, age 26, formerly of Groveland Correctional Facility, charged with Promoting Prison Contraband in the First Degree (D Felony), appeared with his attorney and the matter was adjourned for trial.

KIMBERLY L. DELAVERGNE, age 43, of Mt. Morris was sentenced on a conviction of Grand Larceny in the Third Degree (D Felony) to four months intermittent incarceration and five years probation to include drug treatment court. She was also ordered to pay restitution, a \$325 surcharge and a \$50 DNA fee.

CIRILO HERNANDEZ, age 38, of Hornell, charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Speeding, appeared with his attorney and the matter was adjourned to May 21, 2019.

RYAN S. MCGOY, age 35, formerly of Groveland Correctional Facility, charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (misdemeanor), appeared with his attorney and the matter was adjourned to May 14, 2019 for hearings.

CHRISTOPHER S. POZZI, age 38, of Lindley, charged with Driving While Intoxicated (D Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Operating a Motor Vehicle without an Ignition Interlock Device (Misdemeanor), Driving on Shoulder of the Roadway, and Refusal to Submit to Field Screening Device, appeared with his attorney and the matter was adjourned for hearings.

SHANE QUICK, age 34, of Wayland appeared on a violation of probation and the matter was adjourned to April 30, 2019. He was remanded to the Livingston County Jail without bail.

JASON A. RUFFELL, age 42, of Piffard appeared on a violation of probation and the matter was adjourned to April 30, 2019.

RAYMOND L. SCOTT, age 46, of Dansville was sentenced on a conviction of Sexual Offender Failure to Register or Verify (E Felony) to four months intermittent incarceration and five years probation. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

STEPHEN L. SMYDER, age 51, of Wayland, charged with Grand Larceny in the Fourth Degree (E Felony), appeared with his attorney and the matter was adjourned to April 30, 2019.

JASON F. TEMELKOWSKI, age 37, of Rochester, charged with Identity Theft in the First Degree (D Felony) and Grand Larceny in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to May 21, 2019.

A YOUTHFUL OFFENDER, charged with Rape in the Second Degree (D Felony), appeared with his attorney and the matter was adjourned to April 30, 2019.

CURTIS M. WELCH, age 29, of Rochester pled guilty to Attempted Falsifying Business Records in the First Degree (Misdemeanor) and the matter was adjourned to July 2, 2019 for sentencing.
