DA NEWSLETTER – MAY 2, 2019

After presentation by Justin M. Hill, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Dennis S. Cohen on May 2, 2019.

KIM A. CLARK, age 57, of Wellsville pled guilty to Driving While Intoxicated (E Felony) and the matter was adjourned to July 11, 2019 for sentencing.

KEVIN E. DOLISON, age 23, of Geneseo, charged with two counts of Robbery in the Second Degree (C Felony), Assault in the Second Degree (D Felony), two counts of Grand Larceny in the Fourth Degree (E Felony), and Endangering the Welfare of a Child (Misdemeanor), appeared with his attorney and the matter was adjourned to June 20, 2019 for hearings.

AMBER ELLIS, age 32, of Nunda was sentenced on a Violation of Probation to one to three years in state prison.

DANIEL T. FLYNN, age 35, of Dansville, charged with Grand Larceny in the Third Degree (D Felony), Grand Larceny in the Fourth Degree (E Felony), Unauthorized Use of a Motor Vehicle in the Second Degree (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (E Felony), Leaving the Scene of a Property Damage Accident, and Refusal to Take Breath Test, appeared with his attorney and the matter was adjourned to May 30, 2019 for hearings.

MATTHEW S. MERITT, age 20, of Nunda, charged with Rape in the First Degree (B Felony), Rape in the Second Degree (D Felony) plus additional charges, appeared with his attorney and the matter was adjourned to June 27, 2019 for a hearing.

LEO F. SCHLEDORN, age 30, of Dansville, charged with three counts of Predatory Sexual Assault Against a Child (A Felony) and Use of a Child in a Sexual Performance (C Felony), appeared with his attorney and the matter was adjourned to May 16, 2019 for a hearing.

ARON SMITH, age 48, formerly of Groveland Correctional Facility was sentenced on a conviction of Attempted Promoting Prison Contraband in the First Degree (E Felony) to 1½ to 3 years in state prison as a second felony offender. He was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

TERRY L. STEWART, age 39, of Springwater, charged with two counts of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (Misdemeanor), Speeding, Failure to Comply, Failure to Signal, No Seatbelt, and Refusal to Submit to a Field Screening Test, appeared with his attorney and the matter was adjourned to May 23, 2019 for hearings.

AMANDA S. WILSON, age 37, of Lakeville was sentenced on a conviction of Sex Offender Failure to Register or Verify (E Felony) and a Violation of Probation to eight weekends in the Livingston County Jail and to continue probation. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

SHANNON F. ZENNER, age 43, of Lima was sentenced on a violation probation to continue probation with the addition of Drug Treatment Court.
