After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals on May 15, 2019.

SAMUEL L. BENIGNI, age 52, of Rochester was charged with Grand Larceny in the Third Degree (D Felony).

JAMES L. CASEY, age 49, of Dansville was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Driving While Intoxicated (E Felony), and two counts of Failure to Keep Right.

ALEXANDER K. CASTILLO, age 19, of New York City was charged with two counts of Criminal Sale of a Controlled Substance in the Fifth Degree (D Felony) and two counts of Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony).

ANTONIO R. MASEDA, age 20, of New York City was charged with Criminal Sale of a Controlled Substance in the Fifth Degree (D Felony), Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), and Criminal Sale of Marihuana in the Fourth Degree (Misdemeanor).

SAQAUN N. WEATHERS, age 25, of Rochester was charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony).

After presentation by Gregory J. McCaffrey, District Attorney, the Livingston County Grand Jury handed up indictments on the following individuals (plus 2 sealed indictments) on May 1, 2019.

GENE A. BROWN, age 41, of Rochester was charged with Driving While Intoxicated (E Felony), two counts of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony), Operating a Motor Vehicle with Inadequate Headlights, and Following Too Closely.

BARBARA D. FARO, age 51, of Livonia was charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony), Criminal Possession of a Controlled Substance in the Third Degree (B Felony), and Criminal Sale Marijuana in the Fifth Degree (Misdemeanor).
