**DA NEWSLETTER – MAY 21, 2019**

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on May 21, 2019.

**JOSEPH I. BLIZZARD**, age 32, of Dansville was sentenced on a conviction of Criminal Possession of a Weapon in the Second Degree (C Felony) to 3 ½ years in state prison plus five year post-release supervision. He was also ordered to pay a \$325 penalty assessment and a \$50 DNA fee.

**BAILEE J. BORDEN**, age 23, of Nunda was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) to five years probation. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**ALEXANDER K. CASTILLO**, age 19, of New York City, charged with two counts of Criminal Sale of a Controlled Substance in the Fifth Degree (D Felony) and two counts of Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), appeared with his attorney and the matter was adjourned to June 18, 2019.

**ERICA J. CRESPO**, age 29, of Mt. Morris, charged with Criminal Possession of a Controlled Substance in the Third Degree (B Felony), Criminal Sale of a Controlled Substance in the Third Degree (B Felony), and Bail Jumping in the Second Degree (E Felony), appeared with her attorney and the matter was adjourned to June 4, 2019.

**CARLOS DIAZ-SILVA**, age 35, of Mt. Morris, charged with two counts of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) and two counts of Criminal Sale of a Controlled Substance in the Third Degree (B Felony), appeared with his attorney and the matter was adjourned for hearings.

**KRISTOPHER H. EDELMAN**, age 28, of Rochester, charged with Aggravated Driving with .18 of One Percent or More of Alcohol in His Blood (E Felony), Driving While Intoxicated (E Felony), Aggravated Unlicensed Operation of a Motor Vehicle in the Third Degree (misdemeanor), and Speeding, appeared with his attorney and the matter was adjourned to June 25, 2019.

**BARBARA D. FARO**, age 51, of Livonia, charged with Criminal Sale of a Controlled Substance in the Third Degree (B Felony), Criminal Possession of a Controlled Substance in the Third Degree (B Felony), and Criminal Sale Marijuana in the Fifth Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to June 4, 2019.

**CIRILO HERNANDEZ**, age 38, of Hornell was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree to three years probation. He was also ordered to pay a \$500 fine and an \$88 surcharge.

**PAUL E. LATONE**, age 64, of Conesus was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the First Degree (E Felony) and Driving While Intoxicated (Misdemeanor) to one year incarceration in the Livingston County Jail. He was also ordered to pay a \$520 surcharge, a \$50 DNA fee, and a \$1000 fine. His license was revoked with a requirement to install an Ignition Interlock Device.

**JASON A. RUFFELL**, age 42, of Piffard was sentenced on a violation of probation to four months intermittent incarceration and probation was extended for one year.

**JASON F. TEMELKOWSKI**, age 37, of Rochester, charged with Identity Theft in the First Degree (D Felony) and Grand Larceny in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to June 18, 2019.

**A YOUTHFUL OFFENDER**, charged with Grand Larceny in the Fourth Degree (E Felony), appeared with his attorney and the matter was adjourned to June 18, 2019.
