DA NEWSLETTER – JUNE 18, 2019

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on June 18, 2019.

TRACY L. GRIFFIN, age 37, of Sinclairville, charged with Criminal Possession Controlled Substance Third Degree (B Felony), Criminal Possession of a Controlled Substance in the Fourth Degree (C Felony), Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), Promoting Prison Contraband in the First Degree (D Felony), Tampering with Physical Evidence (E Felony), and Criminal use of Drug Paraphernalia in the Second Degree (Misdemeanor), appeared with her attorney and the matter was adjourned to August 6, 2019.

CONNOR D. HAMBLIN, age 25, of Avon was charged with two counts of Grand Larceny in the Fourth Degree (E Felony) and Petit Larceny (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to July 9, 2019. An Order of Protection was issued for the victim.

ADAM J. KENYON, age 32, of Tonawanda, charged with Criminal Possession of Marijuana Second Degree (D Felony), Criminal Possession Controlled Substance Seventh Degree (Misdemeanor), Unlawful Possession Marijuana, and Insufficient Tail Lamps, appeared with his attorney and the matter was adjourned to June 25, 2019.

ANGEL E. LOPEZ, age 19, of Pennsylvania appeared on a violation of probation and the matter was adjourned to August 6, 2019. He was remanded to the Livingston County Jail without bail.

DAVID R. OLYER, JR., age 36, of Springwater was charged with Assault in the Second Degree (D Felony) and Criminal Possession of a Weapon in the Fourth Degree (Misdemeanor). He was arraigned with his attorney, pled not guilty, and the matter was adjourned to July 23, 2019. An Order of Protection was issued for the victim.

WILLIAM W. PRITCHARD, age 38, of Canaseraga was sentenced on a conviction of Aggravated Unlicensed Operation of a Motor Vehicle in the Second Degree (Misdemeanor) and Driving with .08 of One Percent or More of Alcohol in His Blood (Misdemeanor) to two months intermittent incarceration and three years probation. He was also ordered to pay a \$500 fine and a \$395 surcharge. His license was revoked with a requirement to install an Ignition Interlock Device and he was ordered to attend the DWI Victim Impact Panel.

DEAN L. STEINER, age 50, of Livonia was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Third Degree (B Felony) to four years in state prison plus two years post-release supervision. He was also ordered to pay a \$325 surcharge, a \$50 DNA fee, and restitution.

JASON F. TEMELKOWSKI, age 37, of Rochester, charged with Identity Theft in the First Degree (D Felony) and Grand Larceny in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned for hearings.

CHRISTOPHER J. THOMPSON, age 19, of Leicester was sentenced on a conviction of Rape in the Second Degree (D Felony) time-served and ten years probation to include NYS Sex Offender Registration. He was also order to pay a \$325 surcharge, a \$50 DNA fee, and a \$1,000 supplemental sex offender fee. An Order of Protection was issued for the victim.

A YOUTHFUL OFFENDER pled guilty to Grand Larceny in the Fourth Degree (E Felony) and Attempted Criminal Sale of Marijuana in the Second Degree (E Felony) and the matter was adjourned to August 20, 2019 for sentencing. He was remanded to the Livingston County Jail without bail.
