After presentation by Gregory J. McCaffrey, District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on June 25, 2019.

SAMUEL L. BENIGNI, age 52, of Rochester, charged with Grand Larceny in the Third Degree (D Felony), appeared without an attorney and the matter was adjourned to July 23, 2019.

JOSE DIAZ, age 30, formerly of Groveland Correctional Facility, charged with two counts of Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), appeared with his attorney and the matter was adjourned for hearings.
