**DA NEWSLETTER – AUGUST 20, 2019**

After presentation by Joshua J. Tonra, Assistant District Attorney, the following cases were handled in the Livingston County Court before the Honorable Robert B. Wiggins on August 20, 2019.

**SAMUEL L. BENIGNI**, age 52, of Rochester, charged with Grand Larceny in the Third Degree (D Felony), appeared with his attorney and the matter was adjourned to September 24, 2019.

**ARTHUR E. COLES**, age 29, of Canandaigua was sentenced on a conviction of Driving While Intoxicated (E Felony), Driving with .08 of One Percent or More of Alcohol in His Blood (E Felony), and Throwing Refuse on Highway to four months intermittent incarceration and five years probation to include drug treatment court. He was also ordered to pay a \$2000 fine, a \$520 surcharge and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device and he was ordered to attend the DWI Victim Impact Panel.

**FRANK DONALDS, JR.**, age 24, of Rochester, charged with Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony), appeared with his attorney and the matter was adjourned to September 10, 2019.

**CONNOR D. HAMBLIN**, age 25, of Avon, charged with two counts of Grand Larceny in the Fourth Degree (E Felony) and Petit Larceny (Misdemeanor), appeared with his attorney and the matter was adjourned to October 15, 2019.

**JARED W. HEATH**, age 38, of Dansville, charged with Criminal Possession of a Controlled Substance in the Fourth Degree (C Felony) and two counts of Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), appeared without an attorney and the matter was adjourned to August 27, 2019.

**DAVID R. OLYER, JR.**, age 36, of Springwater, charged with Assault in the Second Degree (D Felony) and Criminal Possession of a Weapon in the Fourth Degree (Misdemeanor), appeared with his attorney and the matter was adjourned for hearings.

**KIMBERLY A. PIOTTER**, age 25, of Rochester was sentenced on a conviction of Criminal Possession of a Controlled Substance in the Fifth Degree (D Felony) to four months intermittent incarceration and five years probation. She was also ordered to pay a \$325 surcharge and a \$50 DNA fee.

**A YOUTHFUL OFFENDER** was sentenced on a conviction of Grand Larceny in the Fourth Degree (E Felony) and Attempted Criminal Sale of Marijuana in the Second Degree (E Felony) to six months in the Livingston County Jail and five years probation. He was also ordered to pay restitution.

**JAMES STONE**, age 23, formerly of Livingston Correctional Facility, charged with Promoting Prison Contraband in the First Degree (D Felony) and Criminal Possession of a Controlled Substance in the Seventh Degree (Misdemeanor), appeared with his attorney and the matter was adjourned to October 1, 2019.

**SCOTT M. WOOD**, age 36, of Mt. Morris was sentenced on a conviction of Driving While Intoxicated (E Felony) to two months intermittent incarceration and five years probation. He was also ordered to pay a \$2,000 fine, a \$520 surcharge and a \$50 DNA fee. His license was revoked with a requirement to install an Ignition Interlock Device and he was ordered to attend the DWI Victim Impact Panel.
